## MINUTES OF THE BOARD OF RECENTS

### MURRAY STATE NORMAL SCHOOL AND TEACHERS COLLEGE

September 14, 1926

The Board of Regents of the Murray State Normal School and Teachers College met in the office of the President at 10:00.A.M. September 14, 1926, as per adjournment, with the following members present: Dr. McHenry Rhoads, Mr. T. H. Stokes, Mr. James F. Wilson and Mr. G. P. Thomas.

### Reading of Minutes

The minutes of previous meeting were read, approved and ordered signed.

Report of Committee on Certification and Graduation

The President presented to the Board a report of the Committee on Certification and Graduation as follows:

September 14, 1926

To the Board of Regents Murray State Normal School and Teachers College

As per the duties of the Committee on Certification and Graduation, we report as follows:

1. We have examined the credentials in reference to age and moral character of each of the persons listed below and it is our opinion that each person fills the requirements in regard to age and moral worth.

2. We have examined the grades and official records of each person listed in this section of the report and recommend that the following persons be granted the <u>STANDARD CERTIFICATE</u>, valid for three years and renewable for life after three years' successful teaching, on conditions set forth in the law, as each has completed the course of study for such a certificate and has at least sixty-four (64) semester hours of credit.

It was moved by Mr. Wilson and seconded by Mr. Stokes that the bid of J. T. Jackson Lumber Company of Lexington, Kentucky, for \$132,000.00 for the construction of the Training School Building be accepted. The roll was called on the adoption of said motion with the following result: Wilson, aye; Stokes, aye; Thomas, aye; Rhoads, aye.

Motion was made by Mr. Stokes and seconded by Mr. Thomas that the bid of Key-Langston Construction Company, Murray, Kentucky, for \$129,225.34 for the construction of the Auditorium Building be accepted. The roll was called upon the adoption of said motion with the following result: Wilson, aye; Stokes, aye; Thomas, aye; Rhoads, aye.

It was further ordered by the Board that the right, in both contracts to accept Option 3 or change to another type of roof, be reserved and that the Board would select the type of roof to be constructed on each of said buildings at some future date.

It was moved by Mr. Stokes and seconded by Mr. Thomas that the bid of Redmon Heating Company, Louisville, Kentucky, of \$24,473.00 for the plumbing and heating in both the Training School and Auditorium Buildings be accepted. The roll was called upon the adoption of said motion with the following result: Wilson, aye; Stokes, aye; Thomas, aye; Rhoads, aye.

Motion was made by Mr. Stokes and seconded by Mr. Wilson that the bid of Harris-Beyer Electric Company of Paducah, Kentucky, of \$8,475.00 for the electric wiring in both the Training School and Auditorium Buildings be accepted. The roll was called upon the adoption of said motion with the following result: Wilson, aye; Stokes, aye; Thomas, aye; Rhoads, aye.

Dr. McHenry Rhoads, Chairman, appointed Mr. James F. Wilson a Committee of one to announce the decisions of the Board of Regents to the bidders present.

#### Contract for Brick

The Board of Regents has inspected samples of face brick and prices thereof, submitted for the consideration of said buildings, and after consideration decided to defer the selection of the face brick.

It was ordered by the Board of Regents that Mr. T. H. Stokes, Mr. James F. Wilson, President Rainey T. Wells and Architect G. Tandy Smith, Jr., be appointed a special committee with full power to secure bids for the furnishing of the face brick, and to let contract therefor and submit their report at the next meeting of this Board.

Architect's Commission on the Auditorium Building

Moved by Mr. Thomas and seconded by Mr. Stokes that the fee and compensation of Mr. G. Tandy Smith, Jr., Architect, for preparing plans and specifications and supervision of the construction of the Auditorium Building and Power Plant be fixed at four per cent of the contract price; that the architect be required to make frequent in-. spection of the construction of said buildings during their construction. The roll was called upon the adoption of said motion with the following result: Wilson, aye; Stokes, aye; Thomas, aye; Rhoads, aye.

Moved by Mr. Wilson and seconded by Mr. Thomas that \$4,000.00 be allowed Mr. G. Tandy Smith, Jr., on architect fees. The roll was called upon the adoption of said motion with the following result: Wilson, aye; Stokes, aye; Thomas, aye; Rhoads, aye.

The Board adjourned to meet at the call of the Chairman.
