MINUTES OF THE BOARD OF REGENTSMURRAY STATE NORMAL SCHOOL AND TEACHERS COLLEGE

March 30, 1928

The Board of Regents of the Murray State Normal School and Teachers College met in the office of the President on Friday, March 30th, 1928, with the following members present: Mrs. Laurine Wells Lovett, Mr. J. F. Wilson, Mr. T. H. Stokes and Mr. W. C. Bell.

Reading of the Minutes

The minutes of the meeting of the Board of Regents on January 27, 1928 were read, approved and signed.

Report of Fire and Tornado Insurance on New Buildings

The President reported for the information of the Board the fire and tornado insurance that has been secured on the new Auditorium, Training School and Heating Plant Buildings and their contents.

Accounts of Contractors for New Buildings

The President made a complete report of the present standing of the accounts of the various contractors for the new buildings.

Insurance for Faculty

The question was raised as to whether it would be a good policy for the Board of Regents to have insurance written on the faculty and employees of this institution. The advisability of taking out group insurance on the members of the faculty was discussed but nothing definite was done about the matter.
