MINUTES OF THE BOARD OF REGENTS

MURRAY STATE NORMAL SCHOOL AND TEACHERS COLLEGE

September 22, 1928

- The Board of Regents met in the office of the President, Saturday, September 22, 1928, with the following members present: Mr. J. F. Wilson, Mr. G. P. Thomas, Mrs. William H. Mason and Mr. G. P. Ordway.

The minutes of the meeting of the Board of Regents on July 20, 1928 were read, approved and signed.

The President presented the report of the Committee on Entrance, Credits, Certification and Graduation and recommended that the certificates be issued and renewed according to the recommendations of the Committee, as follows:

Mr. Wells called to the attention of the Board the fact that when the order for laboratory equipment for the training school was placed with the Kewaunee Manufacturing Company, it was plainly and emphatically stated that this equipment should be delivered and installed by Septem-ber 15, 1928. He advised that he is now in receipt of communication from the Kewaunee Company, dated September 15th, asking for color block showing the finish desired on the equipment, which means of course that the equipment will not be received for quite a while yet.

Mr. Wells reported to the Board that Mr. Lamon Neale, head janitor, has given up his work and gone, and asked for suggestions and advice as to some one suited to fill this position.

Motion was made, seconded and carried that the Board adjourn.
