MINUTES OF THE BOARD OF REGENTSMURRAY STATE NORMAL SCHOOL AND TEACHERS COLLEGE

June 25, 1929

The Board of Regents of the Murray State Normal School and Teachers College met in the office of the President Tuesday, June 25, 1929, with the following members present: Mr. J. F. Wilson, Mr. G. P. Thomas, Mrs. William H. Mason and Mr. G. P. Ordway.

Reading of the Minutes

Report of Additional Insurance on Wells Hall

President Wells reported that, according to previous order of the Board of Regents, the fire insurance upon Rainey T. Wells Hall had been increased from \$100,000.00 to \$200,000.00, except \$15,000.00 to be placed by Mr. Ordway, that this insurance was issued at the new term rate of 2.857% and that it had been distributed among the different agencies, as requested.

Election of Additional Summer School Faculty

President Wells reported that Mr. J. M. Calvin had been employed to teach during the first six weeks of the summer school at a salary of \$60.00 per week, that Miss Julia Shemwell had been employed to teach in the training school during the twelve weeks' summer school at a salary of \$40.00 per week, and Mr. J. B. Cummings had been employed to teach during the twelve weeks' summer school at a salary of \$200.00 per calendar month, and recommended that the Board approve his action and that these persons named above be regularly elected members of the faculty.

Motion was made by Mr. Ordway, and seconded by Mr. Wilson, that Mr. J. M. Calvin be elected a member of the faculty during the first six weeks of the summer school at a salary of \$60.00 per week, Miss Julia Shemwell be elected a member of the faculty during the summer school at a salary of \$40.00 per week, and Mr. J. B. Cummings be elected a member of the faculty during the summer school at a salary of \$200.00 per calendar month, as recommended. The roll call upon the adoption of this motion resulted as follows: Mr. Wilson, aye; Mr. Ordway, aye; Mrs. Mason, aye; Mr. Thomas, aye.

Leaves of Absence

President Wells presented to the Board of Regents the request of Miss Julia Shemwell that she be relieved of her duties as critic teacher in the training school because of having received an appointment in the Civil Service Commission at Washington, D. C.; also the request of Miss Nadine Webb Overall that she be granted a leave of absence from September 15, 1929 to May 31, 1930 in order that she may accept a scholarship offered her to study in the University of Chicago; also the request of Miss Howard Wooldridge that she be relieved of her duties from July 15, 1929 to May 31, 1930.

Motion was made by Mr. Wilson, and seconded by Mr. Ordway, that the requests of the above named members of the faculty be granted and that they be relieved of their duties for the time requested and specified above, without pay. The roll call upon the adoption of

this motion resulted as follows: Mr. Wilson, aye; Mrs. Mason, aye; Mr. Ordway, aye; Mr. Thomas, aye.

Election of Additional Faculty

President Wells recommended the election of the following members of the faculty at the salaries and for the periods of time stated:

Miss Mattie Lou Lockwood as teacher in the training school at a salary of \$2,000.00 per calendar year, beginning September 15, 1929 and continuing until May 31, 1930

Mrs. C. S. Lowry as teacher in the training school, filling the position left vacant by Miss Shemwell, at \$40.00 per week, beginning July 1, 1929 and continuing through the summer school

Motion was made by Mr. Ordway, and seconded by Mr. Wilson, that the President's recommendations for the election of additional members of the faculty be approved and the above named persons be elected at the salaries and for the periods of time recommended. The roll call upon the adoption of this motion resulted as follows: Mr. Wilson, aye; Mrs. Mason, aye; Mr. Ordway, aye; Mr. Thomas, aye.

Bond for Bookstore Keeper

After discussion of the amount of stock carried in the bookstore, the amount of cash handled and the risk taken in the operation of the bookstore, motion was made by Mr. Wilson, and seconded by Mrs. Mason, that the bond of the bookstore keeper be fixed at \$1,000.00 and the premium be paid out of the bookstore fund. The roll was called upon the adoption of this motion with the following result: Mr. Wilson, aye; Mrs. Mason, aye; Mr. Ordway, aye; Mr. Thomas, aye.

Library Building to be Built of Brick with Heavy Stone Trimming

Mr. G. Tandy Smith, Jr., Architect for the Library Building, presented to the Board of Regents additional drawings and plans for this building. After considerable examination and discussion of these plans, motion was made by Mr. Thomas, and seconded by Mrs. Mason, that the Library Building be built of brick with heavy stone trimming. The roll was called upon the adoption of this motion with the following result: Mr. Wilson, aye; Mrs. Mason, aye; Mr. Ordway, aye; Mr. Thomas, aye.

Adjournment

Motion was made, seconded and carried that the Board adjourn to meet again at the call of the Chairman.
