MINUTES OF BOARD OF REGENTSMURRAY STATE NORMAL SCHOOL AND TEACHERS COLLEGE

November 30, 1929

The Board of Regents of the Murray State Normal School and Teachers College met in the office of the President at 2:40 P. M., Saturday, November 30, 1929, with the following members present: Mr. J. F. Wilson, Mr. G. P. Ordway and Mr. W. C. Bell.

Reading of the Minutes

Report of Committee on Entrance, Credits, Certification and Graduation

#### Certificate of Charles McGough

President Wells presented to the Board the following data in reference to the Advanced Certificate of Charles McGough: Mr. McGough has presented to the office of the Registrar evidence of two years' successful teaching experience and the completion of one year of additional college work, since the issuance of his certificate, and his certificate was ordered "renewed", under the heading of a "STANDARD CERTIFICATE", by the Board of Regents at its meeting on July 16, 1929.

As the requirements for an ADVANCED CERTIFICATE were the same as for a STANDARD CERTIFICATE, issued under the present certification law, and as the Attorney General has ruled that two years of teaching experience and one year of additional college work comply, in substance, with the requirement of the law for the renewal of an ADVANCED CERTIFICATE, it was agreed that there was no cause for rescinding the order of the Board on July 16, 1929, renewing Mr. McGough's certificate.

#### Certificate of Mrs. Mary Frances Cothran Dees

President Wells presented to the Board the data in reference to the credits of record at this institution, previously earned by Mrs. Mary Frances Cothran Dees, and asked the advice of the Board in reference to the issuance of a certificate to her.

Motion was made by Mr. Wilson, and seconded by Mr. Ordway, that a COLLEGE ELEMENTARY CERTIFICATE be issued to Mrs. Mary Frances Cothran Dees, dated as of June 30, 1928. The roll call upon the adoption of this motion resulted as follows: Mr. Wilson, aye; Mr. Ordway, aye; Mr. Bell, aye.

#### Equipment for Vault

President Wells took the members of the Board into the vault and called their attention to the need of additional equipment for the proper care of the records, and advised that he had discussed with the Art Metal representative, Mr. Happy, the equipment needed and had him prepare an estimate of the cost.

Motion was made by Mr. Wilson, and seconded by Mr. Ordway that the President be authorized to buy the equipment necessary for the vault.

The roll call upon the adoption of this motion resulted as follows:
