MINUTES OF THE BOARD OF REGENTSMURRAY STATE NORMAL SCHOOL AND TEACHERS COLLEGE

June 10, 1930

The Board of Regents of the Murray State Normal School and Teachers College met in the office of the President at 9:30 A. M., Tuesday, June 10, 1930 with the following members present: Mrs. William H. Mason, Mr. G. P. Ordway, Mr. S. J. Snook and Mr. W. C. Bell. Chairman W. C. Bell presided.

Reading of the Minutes

The minutes of the meetings of the Board of Regents on April 3 and April 7, 1930 were read, approved and signed.

Report of Entrance, Credits, Certification and Graduation Committee

Dr. Wells presented the report of the Committee on Entrance, Credits, Certification and Graduation and recommended that the certificates be issued and renewed according to the following recommendations:

As per the duties assigned to the Committee on Entrance, Credits, Certification and Graduation, we report as follows:

We recommend that the STANDARD CERTIFICATE, issued to Halleene Smith, on July 23, 1926 be extended for life, in accordance with Chapter 87 of the Acts of 1926.

As two Standard Certificates, each valid for three years, have been already issued to her, we set forth the following statement of facts for the consideration of the Board of Regents.

Halleene Smith was issued the Standard Certificate on July 23, 1926. In 1926-27 she taught successfully in Calloway County.

In 1927-28 she attended the Murray State Teachers College for twenty-seven weeks - three fourths of a college year - and earned twenty-six and a half semester hours of standard college work.

In 1928-29 she taught successfully in the Brewers Public School in Marshall County.

She made application for the renewal of her Standard Certificate for life in 1929, but as she had only attended college for twenty-seven weeks, three fourths of a college year, she was refused the renewal of the Standard Certificate for life.

As she had earned more than sixteen semester hours ($26\frac{1}{2}$ semester hours) since the date on which she was granted the Standard Certificate, she was issued another Standard Certificate on August 23, 1929.

In 1929-30 she taught successfully in the Brewers Public School in Marshall County.

She has fulfilled all other legal requirements set forth in Chapter 87 of the Acts of 1926.

Motion was made by Mr. Snook and seconded by Mrs. Mason, that the certificates be issued and renewed as recommended by the Committee. The roll call upon the adoption of this motion resulted as follows: Mrs. Mason, aye; Mr. Ordway, aye; Mr. Snook, aye; Mr. Bell, aye.

Library Stacks

President Wells presented correspondence that he had had with The General Fireproofing Company, Youngstown, Ohio; Albert Pick-Barth Company, Chicago, Illinois; and Snead and Company, Jersey City, New Jersey. After presenting this correspondence, a lengthy discussion was held relative to the following: The Architect's knowledge of preparing plans and specifications for the installation of the library stacks as compared with the knowledge of the representatives of the companies manufacturing these stacks; equipping the Library at this time to meet the demand in the future; type of stacks to be installed; cost; and the using of every precaution to equip it so as to insure the proper poise and dignity.

Dr. Wells recommended to the Board of Regents the advantage to be derived by having the representatives of the different companies appear before the Board and present bids, with their merits, believing that more satisfaction could be obtained from this procedure than to have the Architect prepare plans and specifications relative to the installation of these stacks.

After some discussion, motion was made by Mr. Snook, which was seconded by Mr. Ordway, that the Board concur in the recommendation of the President and that another meeting of the Board of Regents be held on July 10, 1930 for the purpose of having the manufacturers submit their bids for the installation of the library stacks. The roll call upon the adoption of this motion resulted as follows: Mrs. Mason, aye; Mr. Ordway, aye; Mr. Snook, aye; Mr. Bell, aye.

Mr. Joe Boyce as Stone Inspector


Dr. Wells next presented the matter of Mr. Joe Boyce, from the Murray Marble Works, being employed by the Board of Regents to inspect the stone to be used in the construction of the Library Building. After some discussion, Mr. Snook and Mr. Ordway were appointed as a committee to interview Mr. Boyce and obtain some information relative to the time required to inspect the stone and the compensation he would expect therefor. Mr. Snook and Mr. Ordway interviewed Mr. Boyce, but no action was taken as to his employment.

Adjournment

Motion was made, seconded and carried that the Board adjourn to meet again on July 10, 1930.
