MINUTES OF BOARD OF REGENTS  
MURRAY STATE TEACHERS COLLEGE

April 13, 1931

The Board of Regents of the Murray State Teachers College met in the office of the President at 10:40 A. M., Monday, April 13, 1931 with Mrs. William H. Mason, Mr. S. J. Snook and Mr. Claude T. Winslow present. Vice Chairman S. J. Snook presided.

Election of Faculty

Election of Administrative Staff

#### Construction of Curbs and Walks

President Wells reported that the business manager has received bids for the construction of concrete curbs and walks on the campus, and the bids were from 12¢ to 15¢ per square foot on the specifications, and the business manager advised the Board that he had some concrete walk built in the fall at less cost than the lowest bid, and recommended that we have the walks and curbs constructed by the business manager.

Motion was made by Mr. Winslow, and seconded by Mrs. Mason, that the business manager be instructed to build the concrete walks as needed. This motion was unanimously carried.

#### Resignation of Dr. W. Park Richardson

President Wells reported to the Board that Dr. W. Park Richardson had presented his resignation as a member of the faculty with the request that it take effect Wednesday, April 15, 1931.

Motion was made by Mr. Winslow, and seconded by Mrs. Mason, that the request of Dr. Richardson be granted and his resignation be accepted to take effect Wednesday, April 15, 1931. The roll was called

upon the adoption of this motion with the following result: Mrs. Mason, aye; Mr. Winslow, aye; Mr. Snook, aye.

Adjournment

Motion was made, seconded and carried that the Board adjourn to meet again at the call of the Chairman.
