## MINUTES OF BOARD OF REGENTS

#### MURRAY STATE TEACHERS COLLEGE

#### November 6, 1931

The meeting of the Board of Regents was called to order by Vice Chairman S. J. Snook in the office of the President at 10:00 A. M., Friday, November 6, 1931. The members of the Board present were Mrs. William H. Mason, Mr. G. P. Ordway and Mr. S. J. Snook.

President Wells presented to the Board a telegram which he had received from Chairman W. C. Bell advising that he could not meet with the Board today.

## Reading of the Minutes

The reading of the minutes of the last meeting of the Board was postponed until later in the meeting.

#### Finances of the College

President Wells presented to the Board of Regents the financial condition of the institution and discussed with them in detail regarding the finances of the institution for the remainder of the fiscal year.

# Contract for Water and Electricity

President Wells next presented the contract, in triplicate, with the Kentucky-Tennessee Light and Power Company, Murray, Kentucky, the provisions of which have been agreed to by the power company, and recommended that this contract be approved and executed on behalf of the Board of Regents as of July 1, 1931, the expiring date of our former contract.

Motion was made by Mrs. Mason that the written contract with the Kentucky-Tennessee Light and Power Company on behalf of the Board of Regents of the Murray State Teachers College, presented by the President, be approved and that Mr. S. J. Snook and the Secretary of the Board be and are hereby authorized to execute and deliver this contract on behalf of the Board of Regents. This motion was seconded by Mr. Ordway and the roll was called upon its adoption with the following result: Mrs. Mason, aye; Mr. Ordway, aye; Mr. Snook, aye.

## Report of Entrance, Credits, Certification and Graduation Committee

President Wells presented the report of the Certification Committee and recommended that it be accepted and the certificates be issued and renewed according to the following recommendations:

To the Board of Regents Murray State Teachers College:

As per the duties assigned to the Committee on Entrance, Credits, Certification, and Graduation, we report as follows:

1. We have examined the credentials in reference to age and moral character of the persons listed in this section of the report and it is our opinion that each person meets the requirements in regard to age and moral worth.

# Maintenance of Hard Surface Drives

President Wells advised the Board that we have a five-year bond for the maintenance of the hard surface roads and drives built for the college by the Federal Asphalt Paving Company, and he is undertaking to have the company make the needed repairs before the expiration of the bond or else have the bond renewed.

## Roof on Wells Hall

Next, President Wells read to the Board some correspondence which he had had recently with the Johns-Manville Sales Corporation in reference to the proper repair of the roof of Wells Hall and advised that he is endeavoring to get this roof satisfactorily repaired.

## Reading of the Minutes

The minutes of the meeting of the Board of Regents on September 15, 1931 were read, approved and signed.
