#### MINUTES OF BOARD OF REGENTS

#### MURRAY STATE TEACHERS COLLEGE

March 18, 1937

The Board of Regents of Murray State Teachers College met in the office of the President, as per the call of the Chairman, at 10:00 A. M. Thursday, March 18, 1937, with the following members present: Dr. C. E. Crume, Judge Charles Ferguson, Mr. Joe Rogers and Senator T. O. Turner. In the absence of Chairman H. W. Peters, Vice Chairman T. O. Turner presided.

#### Approval of the Minutes

Motion was made by Dr. Crume, and seconded by Mr. Rogers, that the minutes of the meeting of the Board of Regents on January 15, 1937 be approved and signed. This motion was unanimously carried.

# Opening of Bids for Furnishing and Equipping Physical Education Building and Home Economics Building

Mr. H. J. Burt, Office Engineer, representing the Louisville office of the Federal Emergency Administration of Public Works, was present at this meeting to assist in the opening, tabulation and consideration of sealed bids for furnishing and equipping the Physical Education Building and the Home Economics Building, in accordance with specifications which, after approval by the Louisville authorities of the P. W. A., had been mimeographed and furnished to the prospective bidders. Sealed bids, therefore, were opened, tabluated and considered.

### Report of the President

Copies of the report of the President were distributed to the members of the Board of Regents, and the report was read by Dr. Richmond, as follows:

#### REPORT OF THE PRESIDENT

March 18, 1937

The Honorable Board of Regents Murray State Teachers College Murray, Kentucky

#### Gentlemen:

I am submitting the following items for your consideration.

- 1. Opening of bids for equipment of Physical Education and Home Economics Buildings.
- 2. The work of remodeling the President's Home is practically completed, and we are now ready to equip same as soon as the State Purchasing Agent finally passes on bids submitted for this equipment. The Governor has set aside \$12,000.00 for this purpose. Bids have been submitted by three decorators, and are now in the hands of M. C. Howard, State Purchasing Agent.

Out of his own Emergency Fund, the Governor set aside \$3,500.00 for remodeling the President's Home, and, later, \$12,000.00 for decorating it. In short, he has allocated a total of \$15,500.00 to supplement the \$20,000.00 appropriated by the Legislature for the President's Home. I recommend that the Board pass a resolution directing the Secretary to thank the Governor for his generous assistance. I have already extended my own thanks to him, but I think a formal motion of this character would be in order.

The total outlay of State money for buying, remodeling and decorating the President's Home will amount to \$35,500.00, which is a very reasonable figure when compared with the cost of similar enterprises in the state. Upon completion of the President's Home, I am convinced that any competent authority will say that the State has made a sound investment.

- 3. The attendance in the college (second semester) is as follows: 793, college; 373, training school. I consider this a remarkable enrollment. It is true that we had every I consider as follows: right to expect approximately 1,100 students to enroll for the second semester; but the ravages of the flood, which came to a climax at the very time that we were enrolling students for this semester, caused many of us to feel that we would be fortunate to have an enrollment of 600. Not only were many prospective students prevented from coming because of the flood and the damage it had wrought; but scores, already enrolled in the college, through panic, lack of money and from other causes, either left school or were contem-In order to meet the economic problem plating leaving. presented by the flood, I requested the N. Y. A. authorities in Louisville and Washington, going to Washington, personally, to see the federal authorities, that they give us additional N. Y. A. workships. I asked for 125, and we were promptly granted 115 workships. This generous attitude on the part of the federal government undoubtedly made it possible for many students to continue in college, or to come to college, who, otherwise, would have been denied that privilege.
- 4. The Physical Education and Home Economics Buildings are practically finished. The flood conditions have made it necessary for your Executive Committee to request an additional extension of time sixty days additional from March 15.

  To date, we have not had a reply to this request, but I am confident that it will be granted. Many irritations and complications have arisen with reference to the construction of these buildings. Numerous leaks have appeared from time to time in the buildings, and some of the floors of the Physical Education Building are badly buckled. Under the circumstances, I felt that our Architect and the representative of the P. W. A. should be here at this time to advise with us concerning some of these problems, and I have requested them to be here today. Your President and Business Manager have kept in close touch with the building situation and have had frequent conferences with the Architect, the Contractor and the Federal Government representative on the project. I am insisting that these projects be brought to full completion as speedily as possible. Due to delays, caused in part by the flood, we are several weeks behind in the completion of these buildings; and, as a result, are losing \$16.11 interest each day.
- 5. Report of Entrance, Credits, Certification and Graduation Committee.
- 6. I am presenting for your approval the bond of Miss Alice Keys as Treasurer of the Board of Regents of Murray State Teachers College, executed by United States Fidelity and Guaranty Company, Baltimore, Maryland, in the sum of \$10,000.00.

- 7. Your President has received and accepted the resignations of O. B. Irvan, Jr., and Nolan Jetton, Foremen for Janitorial Work, with additional duties covering inspection, repairs, etc. Mr. Irvan was a very valuable man; the work of Mr. Jetton, however, was not very satisfactory. In Mr. Irvan's place, under the authority given me by this Board, I have appointed Mr. Ira Morgan on a temporary basis. To date, he is doing his work well, and the fact that he has some ability as a carpenter makes his services quite advantageous to the college. Due to our restricted budget, I am recommending to the Board that, for the time being, at least, Mr. Jetton's place remain unfilled.
  - 8. Business Manager's report.
- 9. It has just come to my attention that the employment of Miss Kay Rudolph as Secretary to the Director of Extension has not been officially reported to the Board of Regents. Under the authority given me by this Board, she was employed at a salary of \$60.00 per calendar month, beginning November 9, 1936.
- 10. Our supply of catalogues is practically exhausted; and I am recommending to the Board that they authorize me to prepare a new catalogue and make the proper requisition for its printing.
- 11. Election of President to presidency of Murray Chamber of Commerce and, also, Tennessee Valley Association.

The general situation at the college is good. No serious problems of discipline have presented themselves. The health of the student body is, in the main, excellent; and the work in the classes is progressing in a fairly satisfactory fashion. It is our hope and belief that many students, temporarily prevented from enrolling in the college for the second semester, will enter in April for the last quarter, in which event it may be necessary to organize some additional classes; and there is a bare possibility that one or two temporary instructors will have to be provided.

Report of Committee on Entrance, Credits, Certification and Graduation

#### Bond of Miss Alice Keys, Treasurer, Accepted

Motion was made by Mr. Rogers that the Board accept the bond of Miss Alice Keys, Treasurer, which was executed by United States Fidelity and Guaranty Company, Baltimore, Maryland, in the sum of \$10,000.00. This motion was seconded by Dr. Crume, and the roll was called on its adoption with the following result: Dr. Crume, aye; Judge Ferguson, aye; Mr. Rogers, aye; Senator Turner, aye.

#### Rental of Stadium Flood Lights by Curlee Clothing Company

Dr. Richmond read to the Board a letter from Acree Austin, Athletic Director, Curlee Clothing Company, Mayfield, Kentucky, offering to rent the Stadium flood lights during the summer.

Motion was made by Mr. Rogers that the business management of the college, if they see fit, may contract with the Curlee Clothing Company of Mayfield, Kentucky, for the rental of the flood lights from the football field of the Stadium provided this company will equip and replace these lights and have them ready for use by the time it is necessary for us to use them next fall. This motion was seconded by Judge Ferguson, and the roll was called on its adoption with the following result: Dr. Crume, aye; Judge Ferguson, aye; Mr. Rogers, aye; Senator Turner, aye.

#### New Catalogue To Be Published

Motion was made by Dr. Crume that the President be authorized to publish a new college catalogue. This motion was seconded by Mr. Rogers, and the roll was called on its adoption with the following result: Dr. Crume, aye; Judge Ferguson, aye; Mr. Rogers, aye; Senator Turner, aye.

#### Mr. R. A. Johnston Granted Extension of Leave of Absence

Dr. Richmond reported to the Board that Mr. R. A. Johnston, who had been granted a leave of absence for the first semester, wrote him before the close of that semester requesting that his leave be extended through the second semester, also, and that he had tentatively granted that extension.

Motion was made by Dr. Crume that the leave of absence of Mr. R. A. Johnston be extended for another semester on the same basis as before, until June 4, 1937. This motion was seconded by Judge Ferguson, and the roll was called on its adoption with the following result: Dr. Crume, aye; Judge Ferguson, aye; Mr. Rogers, aye; Senator Turner, aye.

Dear Mr. Hortin:

I am calling your attention in this communication to a most remarkable and very creditable record which has been made by certain graduates of this institution. I refer to our pre-med graduates. Not a single student who completed all of his pre-med or pre-dental work at Murray has ever flunked his professional training. As you well know many of our students have gone to medical and dental schools at Vanderbilt, Louisville, Tennessee, and other outstanding institutions. Some of these students have graduated and are now practicing successfully. Others are at these schools now, and many others are now enrolled at Murray for their preliminary work.

### Progress on Physical Education and Home Economics Buildings

Mr. H. A. Wortham, Legal Counsel from the Louisville office of the P. W. A., Mr. Leo. F. Whalen, Resident Engineer of the P. W. A., and Mr. G. Tandy Smith, Architect, were called before the Board of Regents for a discussion of the progress on the construction of the Physical Education and the Home Economics Buildings.

Mr. G. Tandy Smith reported that the flood had seriously interfered with the completion of these buildings. The shipment of the grate bars was held up, he said, but they have just recently installed these grate bars and arranged for heat in the buildings. The buildings might have been completed before the flood, Mr. Smith said; but, still, he added off-hand that it would be thirty days before they could be completed. The floors, as laid down, were not even enough for the purpose for which they were built, he stated; and the flooring was laid when the building was in a damp condition - both the concrete foundation and the brickwork were damp, there was no heat to dry them out, and the roof was not on the building. He said the contractor took a chance on laying these floors under the unfavorable conditions mentioned; he gambled on the weather and lost.

Mr. H. A. Wortham said that, as an inspector for the Government, he could not accept the floors, not only on the first floor but all the floors in the Physical Education Building. He reported that since writing his letter, commenting on conditions which should be improved, he had found some other things that were not in proper condition.

Mr. Smith added that, as Mr. Wortham stated, there are a lot of things that are not right; but, as yet, he had made no effort to make anything like a final inspection, and that when the buildings are nearer completed, he would make other inspections and see that these deficiencies are corrected.

Mr. Wortham added that his division is responsible for expediting the completion of jobs. He said that the flood is over, and the government is going to insist that this project is completed without delay, and, if it is not done, it will be our responsibility to see that this docket is speedily completed.

Dr. Richmond stated that, as President of this college and as a responsible agent of this Board, he was recommending that our Architect be directed to see to it that these buildings are completed as expeditiously as possible, that no delay be tolerated, that this notification be carried to the contractor, and that every possible effort be made by the Architect and the Contractor to see to it that this project is completed within the next thirty days or less. Dr. Richmond recommended to the Board that they notify Mr. Cole, through our Architect, that we are not going to accept those floors until they are right. Dr. Richmond then strengthened his statement by recommending to the Board that they request the Architect to make the demand of Mr. Cole to re-lay the floors in the Physical Education Building.

#### Board Recessed for Lunch

Motion was made by Dr. Crume that the Board recess until 1:15 P. M. for lunch and for time to inspect the floors of these buildings. This motion was seconded by Mr. Rogers, and carried unanimously.

## Change Order on Physical Education and Home Economics Buildings

The Board reconvened at 1:15 P. M. and gave consideration first to some suggested changes in the Physical Education Building and the Home Economics Building, Docket No. Ky-1062-R, which Mr. G. Tandy Smith, Jr., Architect, stated were highly desirable. Mr. Smith enumerated the desired changes and gave the cost thereof, as follows:

- (a) Plastering on N.W. Vestibule Physical Education .
  Building and building up a little brick wall \$128.19
- (b) Close 12 windows in handball court 60.00
- (c) Place door in visiting team room 41.50
- (d) Place drain tile in the front trench and down to the street
- (e) Omit pantry and closet in the Home Economics
  Building kitchen and put in a little serving
  pantry
  31.49
- (f) Install two chrome ladders in shallow end of swimming pool, same as ladders in deep end, Physical Education Building

Motion was made by Mr. Rogers that the Board of Regents approve the changes in the Physical Education Building and in the Home Economics Building, as recommended by the Architect. This motion was seconded by Dr. Crume, and the roll was called on its adoption with the following result: Dr. Crume, aye; Judge Ferguson, aye; Mr. Rogers, aye; Senator Turner, aye.

Dr. Richmond called attention to the fact that the specifications did not call for tile at the entrance of the showers, and that it was his opinion that this tile was very necessary and should yet be included in this change order. The President suggested that, with the agreement of this Board, Mr. Smith be directed to include in the Change Order the installation of this tile at a cost not to exceed \$30.00.

Motion was made by Judge Ferguson that the tile at the entrance of the showers be included in the Change Order just approved. This motion was seconded by Dr. Crume, and the roll was called on its adoption with the following result: Dr. Crume, aye; Judge Ferguson, aye; Mr. Rogers, aye; Senator Turner, aye.

Mr. Stewart pointed out to the Board the necessity for placing a door for another entrance into the Women's Gymnasium, and placing a wash basin in each suite of offices in the Physical Education Building and in the Freshman dressing room.

Dr. Richmond suggested that the Chairman delegate consideration of these Change Orders that Mr. Stewart has suggested, and, if they are decided necessary, they be included in the Change Order just approved.

Motion was made by Dr. Crume that the President's suggestion with reference to adding another door to the Women's Gymnasium and placing a wash basin in each suite

of offices and in the freshman dressing room of the Physical Education Building, be approved and the Executive Committee be authorized to add these changes to the approved Change Order if it is thought best. This motion was seconded by Mr. Rogers, and the roll was called on its adoption with the following result: Dr. Crume, aye; Judge Ferguson, aye; Mr. Rogers, aye; Senator Turner, aye.

# Bids Accepted for Furnishing and Equipping Physical Education Building and Home Economics Building

After closely studying and comparing the various bids for furnishing and equipping the Physical Education Building and the Home Economics Building, and examining the quality of merchandise offered in some instances, motion was made by Dr. Crume that the Board accept the lowest and best bid for the various items and groups of furniture and equipment (where necessary to purchase by groups) said lowest and best bid being indicated by a star (\*) immediately following the price quoted. This motion was seconded by Judge Ferguson, and the roll was called on its adoption with the following result: Dr. Crume, aye; Judge Ferguson, aye; Mr. Rogers, aye; Senator Turner, aye. This motion was carried unanimously, and the tabulated bids follow, stars having been placed just following the items or groups which the Board of Regents recommends purchasing.
