MINUTES OF BOARD OF REGENTS
MURRAY STATE TEACHERS COLLEGE

April 23, 1941

The Board of Regents of Murray State Teachers College met in the office of the President at 10:00 A. M. Wednesday, April 23, 1941, as per the call of the Chairman, with the full membership present, as follows: Dr. C. E. Crume, Judge Charles Ferguson, Mr. Claude Winslow, Mr. George Hart and Honorable J. W. Brooker. Chairman J. W. Brooker presided.

Report of the President

Dr. James H. Richmond presented and read his report as President, as follows:

REPORT OF THE PRESIDENT

April 23, 1941

Honorable Board of Regents
Murray State Teachers College
Murray, Kentucky

Gentlemen:

I am submitting the following items for your information and consideration:

I. Approval of the Minutes of the Board of Regents for the meeting held April 10, 1941

The National Youth Administrator, Washington, D. C., has urged me to come to his office for a conference on April 28 and 29, therefore, it was necessary that the date for the regular quarterly meeting of the Board of Regents be moved up, and for this reason the Minutes of the Board for the meeting held on April 10, 1941 are not yet copied in the Minute Book ready for approval.

II. Fine Arts Building

The instructions of the Board of Regents in connection with the proposed construction of the Fine Arts Building have been carried out as rapidly as possible. As you know, \$60,000.00 of 3% Fine Arts Building Revenue Bonds have been sold, subject to the approval of the application of the college for W. P. A. funds to aid in the construction of this building. This application is still in the hands of W. P. A. officials, but we hope soon to be able to start actual construction.

a. Division of Funds for Construction of Bldg.

III. Renewal of Contract with Tennessee Valley Authority and Kentucky Library Extension Division for Regional Library Service

As the present contract with the Tennessee Valley Authority and the Kentucky Library Extension

Division for regional library service in this area will soon expire, I am submitting for your consideration a proposed contract for the continuation of this service throughout the coming fiscal year, beginning July 1, 1941 and ending June 30, 1942. This contract, which is substantially the same as the one now in effect, meets the approval of the college librarian, and I am recommending that it be approved by the Board of Regents.

IV. Commencement

I have made arrangements for Dr. Wm. J. Hutchins, former President of Berea College, who is now associated with the Danforth Foundation, to preach our Baccalaureate Sermon on Sunday, June 1, 1941, and Dr. Charles W. Welch, Pastor of the Fourth Avenue Presbyterian Church, Louisville, Kentucky, will deliver our Commencement Address on Thursday, June 5, using as his subject, "Spiritually Understanding a Disordered World".

V. Length of Summer Session of 1941

Over my objection, the Council on Public Higher Education has ruled that the length of the 1941 summer session of Kentucky colleges shall be ten weeks, therefore, our summer school will be composed of two terms of five weeks each, the first one beginning June 16 and continuing through July 18, and the second opening July 21 and closing August 22. Under present conditions, I think this is too long, but our plans and announcements have been made in accordance with the decision of the Council.

VI. Leaves of Absence

- a. Miss Mayrell Johnson has asked for a leave of absence from her duties in the Social Science Department, beginning June 16 and continuing through August 22, 1941, in order that she may do graduate work at the University of Kentucky. Under authority granted me by the Board of Regents, I have granted this leave of absence in accordance with Miss Johnson's request.
- b. Miss Carrie Allison has requested a leave of absence for the second term of the summer session, beginning July 21 and continuing through August 22, 1941, and I have granted the leave as requested.

VII. Employment of Faculty and Staff; Budget for 1941-42

In submitting my recommendations for the employment of the faculty and staff, I am recommending that the various individuals be employed to the positions indicated at the salaries and for the periods of time specified in the attached report.

I am submitting a tentative budget for the operation of this college during the fiscal year beginning July 1, 1941 and ending June 30, 1942.

In case it becomes necessary to modify this budget between now and July 1, further recommendations will be submitted to the Board of Regents at a later meeting. I am recommending the adoption of this tentative budget which is herewith attached.

Approval of the Minutes

The reading and approval of the Minutes of the Board of Regents for the meeting held on April 10, 1941 were postponed for the reason explained by the President.

Division of Funds for Construction of Fine Arts Building between Bank of Murray and Peoples Savings Bank

Dr. Richmond called attention to the fact that heretofore the funds for the construction of building projects at the college had been divided between the two local banks and the Board of Regents might want to authorize such a division of funds in connection with the Fine Arts Building.

Motion was made by Mr. Winslow that the funds for the construction of the Fine Arts Building be divided equally between the two local banks, the Bank of Murray and the Peoples Savings Bank. This motion was seconded by Mr. Hart and was carried unanimously.

Contract for Regional Library Service in Cooperation with the Tennessee Valley Authority and the Kentucky Library Extension Division Approved

Motion was made by Mr. Hart that the contract for regional library service in cooperation with the Tennessee Valley Authority and the Kentucky Library Extension Division be approved, as submitted, and that the President be authorized to sign this contract. This motion was seconded by Dr. Crume, and the roll was called on its adoption with the following result: Dr. Crume, aye; Judge Ferguson, aye; Mr. Winslow, aye; Mr. Hart, aye; Mr. Brooker, aye.

College Post Office

Dr. Richmond called attention again to the post office situation here at the college, explaining that the federal government is paying only \$780.00 toward the cost of operating the college post office (postmaster's salary), whereas the college spends \$543.00 to supplement the postmaster's salary and provide a student assistant for him in addition to furnishing the space and equipment for the post office and the water, light and heat. Dr. Richmond reported that

he had taken up this matter with Congressman N. J. Gregory with the idea of getting a more equitable arrangement for handling the mail, that at first he was encouraged to think a better plan could be worked out, but that later communications from Mr. Gregory did not indicate much chance for making a change in the present system of operation here. He suggested that when he went to Washington he might see the various authorities there and find out what can be done about our post office situation so that he would be in position to make a definite recommendation at a later meeting of the Board of Regents.

Motion was made by Mr. Hart that the President be authorized and directed to take up the post office situation at Murray State Teachers College with the proper authorities in Washington and see what improvement can be worked out. This motion was seconded by Dr. Crume and was carried unanimously.

Report of Thomas P. Norris Student Loan Fund

At this point, Dr. Richmond called on Mr. R. E. Broach, Custodian of the Thomas P. Norris Student Loan Fund, to report on the condition of this fund, which he did, as follows:




Budget for 1941-42 Approved; Faculty and Administrative Staff Employed
