MINUTES OF THE BOARD OF REGENTS

MURRAY STATE TEACHERS COLLEGE

March 13, 1947

The Board of Regents of the Murray State Teachers College met in special session in the office of the President at 10:00 a. m. on Thursday, March 13, 1947, as per the call of the Chairman. Mr. Claude Winslow, Mr. Maxon Price, General Hubert Meredith, and Judge Charles Ferguson were present. In the absence of Chairman John Fred Williams, Vice Chairman Charles Ferguson presided.

President's Report

Dr. Ralph H. Woods presented and read his report as President, as follows:

L. L. Reeder, Fireman, beginning March 6, 1947, at a salary of \$90.00 per calendar month.

Marvin Houston, Painter, beginning March 1, 1947, at a salary of \$135.00 per calendar month.

R. C. Moore, Carpenter, beginning March 1, 1947, at a salary of \$135.00 per calendar month.

James T. Stone, Carpenter, beginning March 1, 1947, at a salary of \$135.00 per calendar month.

Mrs. Louise C. Cothran's salary was changed from \$12.50 to \$30.00 per calendar month, effective January 1, 1947.

James E. Brandon's salary was changed from \$93.20 to \$100.00, effective February 1, 1947, and transferred from Dishwasher to Fireman.

Miss Tennie Breckenridge's salary was changed from \$160.00 to \$175.00 per calendar month, effective March 1, 1947.

Miss Oneida Wear's salary was changed from \$140.00 to \$150.00 per calendar month, effective March 1, 1947.

Mrs. Margaret P. Blalock's salary was changed from \$100.00 to \$120.00 per calendar month, effective February 1, 1947.

Miss Ruth Ashmore's salary was changed from \$110.00 to \$125.00 per calendar month, effective February 1, 1947, with additional duties assigned with the veterans testing program.

James Robert Endicott and Harding Cole Williams were assigned additional duties with the veterans testing program with salaries of each changed from \$32.50 to \$65.00 per calendar month, effective February 1, 1947.

V. American Association of Teachers Colleges Adopts New Schedules of Fees for Institutional Membership

The American Association of Teachers Colleges has adopted a new schedule of fees which are to go into effect in 1947 based on enrollment. As we have an enrollment of more than 1000, our membership fee will be \$250.00, to be paid annually.

The deed and abstract have been approved by the Attorney General and the deed has been recorded in the office of the Clerk of the Calloway County Court and filed in the office of the Secretary of State.

Approval of Minutes

Motion was made by Mr. Winslow that the Minutes of the Board of Regents for the meeting held on January 20, 1947, copies of which were mailed to the individual members of the Board, be approved and signed. This motion was seconded by General Meredith, and was carried unanimously.

Resignations

Dr. Woods presented to the Board the resignations that had come to him since the last meeting and stated that these had been accepted by him under authority given previously by the Board.

Motion was made by Mr. Price that the resignations accepted by Dr. Woods be approved. This motion was seconded by Mr. Winslow and was carried unanimously.

Employment, Changes and Adjustments in Salary Approved

Motion was made by Mr. Winslow that the employment of certain persons and changes and adjustments in salary be approved as reported by the President in Item IV of his report. This motion was seconded by General Meredith, and the roll was called on its adoption with the following result: Mr. Price, aye; Mr. Winslow, aye; General Meredith, aye; Judge Ferguson, aye.

American Association of Teachers Colleges' Annual Membership Fee to be Paid

Motion was made by Mr. Price that the annual fee of \$250.00 for membership in the American Association of Teachers College, based on enrollment, which has recently gone into effect, be paid. This motion was seconded by Mr. Winslow, and the roll was called on its adoption with the following result: Mr. Price, aye; Mr. Winslow, aye; General Meredith, aye; Judge Ferguson, aye.

Insurance on Bonded Buildings

Motion was made by Mr. Winslow that the Board authorize the President and the Business Manager to increase the amount of insurance on the bonded buildings from \$466,700.00 to \$668,200.00 and to distribute this amount of insurance in a way which would be most equitable to those agencies which now have this insurance and to place a portion of the increased amount of insurance in the immediate locality (companies mentioned were the Murray Insurance Agency and the Berry Insurance Agency). This motion was seconded by General Meredith, and the roll was called on its adoption with the following result: Mr. Price, aye; Mr. Winslow, aye; General Meredith, aye; Judge Ferguson, aye.

Insurance on All Buildings Other Than Those Bonded

Motion was made by Mr. Winslow that the Board authorize the President and the Business Manager to make the needed adjustments in the evaluation of all buildings other than the bonded buildings and to increase the amount of insurance from \$1,215,905.00 to \$1,505,805.00 in the State Fire and Tornado Insurance Fund. This motion was seconded by Mr. Price, and the roll was called on its adoption with the following result: Mr. Price, aye; Mr. Winslow, aye; General Meredith, aye; Judge Ferguson, aye.

Kentucky Ordnance Works: Contract for Acquiring Buildings T-705 and T-719

Motion was made by Mr. Winslow that the Board authorize the President to sign the necessary contract (Agreement of Sale, WAS-17-(P)-59) with the United States of America acting by and through War Assets Administration to acquire two (2) temporary wood buildings located at the Kentucky Ordnance Works, in McCracken County, Kentucky, No. T-705, formerly used as employment building, one story with approximately 8,700 square feet of floor area, and No. T-719, formerly used as medical building, one story with approximately 7,700 square feet of floor area. This motion was seconded by Mr. Price, and the roll was called on its adoption with the following result: Mr. Price, aye; Mr. Winslow, aye; General Meredith, aye; Judge Ferguson, aye.

Proposal of Stein Bros. & Boyce, Louisville, Presented to the Board

The proposal of Stein Bros. & Boyce, Louisville, Kentucky, in connection with the enlarging of Warren S. Swann Memorial Dormitory, was presented and read to the Board by Mr. Harold Sullivan, representative of Stein Bros. & Boyce.

Proposal of Stein Bros. & Boyce Accepted and Signed

After discussing the proposal of Stein Bros & Boyce, in connection with the enlarging of Warren S. Swann Memorial Dormitory, thereupon it was moved by Mr. C. T. Winslow and seconded by Mr. Maxon Price, that the following resolution be adopted:

WHEREAS, Stein Bros. & Boyce and Bankers Bond Company of Louisville, Kentucky have presented a proposal to the Board deemed for its best interest in order to accomplish its plan of issuing Dormitory Revenue Bonds.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Regents of the Murray State Teachers College accept and it hereby accepts said proposal dated March 13, 1947, a copy of which follows herewith and is made a part of these minutes -

Gentlemen:

We present the following proposal for your consideration at your meeting on March 13, 1947:

We understand that you desire to enlarge the Warren S. Swann Memorial Dormitory which cost will be approximately \$25,000. You now have outstanding \$35,000 of Dormitory Revenue Bonds, which bonds bear an interest rate of 3% and mature \$3,000 June 1, 1947, \$4,000 June 1, 1948 through 1950, \$5,000 June 1, 1951 through 1954; these bonds could be called at 102 and refunded at lower interest rates.

We submit to you the following proposal: We will cause to be prepared an authorized issue of approximately \$60,000 of Dormitory Revenue Bonds; the bonds to mature serially from 1 to 10 years, as mutually agreed upon, bearing interest at the rate of not to exceed 2 1/4% per annum; interest payable semi-annually. Bonds maturing after ten years to bear interest at the rate of 2 1/2%.

Said bonds shall be callable at 103 for the first five years and at 102 for the second five years, thereafter at 101, in inverse order of maturities.

We and our attorneys will do all the work incident to the preparation of the bonds including the preparation of all resolutions and notice of sale. We will pay all expenses incident to this work, including the cost of printing of the bonds, cost of publicly advertising same for sale, cost of the approving legal opinion issued in connection with said bonds and any and all other expenses that may be incurred in the issuance and sale of said bonds.

The Board of Regents of the Murray State Teachers College and the officials of the Murray State Teachers College are to cooperate with us and our attorneys in furnishing any information that is needed or which is required, and they hereby authorize the publishing of the notice of call.

If the public sale is held within 45 days from the date of this proposal, we will guarantee a bid to the Board of Regents of Murray State Teachers College of at least 103 and interest. We are to be paid an amount equal to 3% of the face value of the issue for our services, expenses and risk.

It is understood that we are not to be prevented from bidding at the competitive sales of the proposed bond issue. Whether or not we are the highest and best bidder for bonds at said public sale, a sum equal to 3% of the face amount of the bonds sold is to be paid to us immediately upon delivery of the bonds to the successful bidder in payment therefor.

This proposal is made subject to the bonds being approved as to legality by our attorneys. In the event that prior to the delivery of such bonds sold at the public sale the income received by private holders from bonds of the same type and character shall be taxable under any Federal or Kentucky Income Tax law, or such bonds shall be subject to Kentucky ad valorem taxes, the successful bidder may at his election be relieved of his obligation to purchase such bonds. At the present time such bonds are free of said taxes and said provision is necessary because of the great difference in value between exempt and taxable bonds.

Present Outstanding Dormitory Refunding Revenue Bonds Ordered to Be Called

Motion was made by Mr. Winslow that the Board of Regents call for redemption as of June 1, 1947, all of its outstanding Dormitory Refunding Revenue Bonds, dated September 1, 1940, bearing interest at the rate of 3% per annum, of the denomination of \$1000.00 and numbered consecutively from 19 to 50 inclusive, and that public notice be given to this effect. This motion was seconded by Mr. Price, and the roll was called on its adoption with the following result: Mr. Price, aye; Mr. Winslow, aye; General Meredith, aye; Judge Ferguson, aye.

Plans and Specifications for Enlarging Warren S. Swann Memorial Dormitory Authorized

Motion was made by General Meredith that the Board authorize Dr. Woods to employ someone to draw up plans and specifications to enlarge Warren S. Swann Memorial Dormitory and pay for same out of proceeds of the bond issue. This motion was seconded by Mr. Price and the roll was called on its adoption with the following result: Mr. Price, aye; Mr. Winslow, aye; General Meredith, aye; Judge Ferguson, aye.

Salary Adjustments Schedule Approved

Dr. Woods presented to the Board a report of the anticipated revenue and anticipated expenditures for the period from February 1, 1947, through June 30, 1947. He also presented a schedule of proposed salary payments for the teaching staff for the months of March, April, and May, 1947, and for the Administrative Staff and the Maintenance Staff for the months of April, May, and June, 1947, and recommended that this schedule be approved.

Motion was made by General Meredith that the Board authorize the President to have plans and specifications for the construction of the proposed Science Building prepared and follow the necessary legal steps in advertising and procuring bids from reputable contractors for the erection of the Science Building, subject to the approval of the Commissioner of Finance of the State of Kentucky and of the Attorney General of the Commonwealth of Kentucky as to legality and the right to encumber the capital outlay funds now on hand approved by the Legislature. This motion was seconded by Mr. Winslow, and the roll was called on its adoption with the following result: Mr. Price, aye; Mr. Winslow, aye; General Meredith, aye; Judge Ferguson, aye.

Attorney General's Opinion re: Ventilating and Cooling Equipment In Fine Arts Building and Installing New Bleachers in Health Building

Dr. Woods read a letter, dated February 4, 1947, from the Honorable Eldon S. Dummitt, Attorney General, which was in reply to his letters of January 23 and 29, 1947, concerning expenditures for ventilating and cooling equipment for the Fine Arts Building and for installing new bleachers in the Health Building to be paid out of the surpluses in the two accounts. The Attorney General stated in his letter that it was his opinion that the college would be justified in making the above expenditures from the surpluses of the two accounts.
