MINUTES OF THE MEETING OF THE BOARD OF REGENTS MURRAY STATE UNIVERSITY August 8, 1980

The Board of Regents of Murray State University met August 8, 1980, at 10:00 a.m. in the Board of Regents Suite, Third Floor, Wells Hall, on the campus of the University. The following members were present: Mr. J. W. Carneal, Mr. Ron Christopher, Mr. Terry Clark, Mr. Bob T. Long, Mr. Jere McCuiston, Mr. Bill Morgan, Mrs. Sara Page, Mr. Steve West, and Dr. Charles E. Howard, Chairman, presiding.

Absent was Dr. Ed Settle.

Also present were Dr. Constantine W. Curris, President; Mrs. Patsy R. Dyer, Secretary of the Board; Dr. Richard C. Gray, Treasurer of the Board and Vice-President for Administrative Services; Vice-Presidents Richard Butwell, Marshall Gordon, and Frank Julian; Mr. James Overby, University Attorney; Mr. Don Chamberlain; Dr. Rick Stinchfield; Mr. Jim Hall; Dr. Ken Purcell, President, Faculty Senate; and members of the news media and visitors.

Chairman Howard called the meeting to order and President Curris led in prayer.

Oath of Office administered to Mr. Bill Morgan and Mrs. Sara Page

Mrs. Patsy R. Dyer, Notary Public, administered the Oath of Office to Mrs. Sara Lowry Page and Mr. Billy Brandon Morgan.

On May 19, 1980, Governor John Y. Brown, Jr. reappointed Dr. Charles E. Howard as a member of the Murray State University Board of Regents and appointed Mrs. Sara Lowry Page of Paducah as a member of the Board of Regents replacing Mr. A. B. Mitchell. Dr. Howard and Mrs. Page were appointed for four-year terms ending March 31, 1984.

On July 8, 1980, Governor Brown appointed Mr. Billy Brandon Morgan, Benton, as a member of the Murray State University Board of Regents to replace O. B. Springer. Mr. Morgan was appointed for a four-year term ending June 30, 1984.

Chairman Howard welcomed Mrs. Page and Mr. Morgan to the Board.

Reorganization of the Board of Regents

Chairman Howard appointed Dr. Curris temporary chairman of the Board for the election of officers.

President Curris stated that there are four officers of the Murray State University Board of Regents and they are currently held by the following: Chairman, Dr. Charles E. Howard; Vice-Chairman, Mr. J. W. Carneal; Secretary, Mrs. Patsy R. Dyer; and Treasurer, Dr. Richard C. Gray. He stated that the floor is now open for nominations.

Mr. Long moved that the four incumbent officers be reelected to their positions. Mr. Christopher seconded and upon call for the question, the motion carried.

Chairman Howard expressed appreciation to the members for their confidence in the officers of the Board.

11. Replacement of Summer Professional Leave program with a Faculty Development Grant program

I recommend that the Board of Regents eliminate the Summer Professional Leave Program (as amended March 5, 1977) and replace that program with a competitive grants program known as the Faculty Development Grants program. Such action will strengthen faculty development activities while effecting annual budgetary savings.

Faculty Professional Development Grant Program

The Faculty Professional Development Grant Program is funded by the Board of Regents for the purpose of promoting the professional growth and development of its faculty in the areas of teaching, research, and public service.

The program provides summary grant awards on the basis of competitive review. Eligibility is limited to faculty who have completed eight semesters of continuous full-time academic service at Murray State University. Eight semesters of full-time academic service must be performed following previous grant awards to establish eligibility for an additional award.

Faculty Professional Development grants are to be utilized for approved full-time professional activities for a two-month's period (June and July). Grant awards shall be equivalent to full-time summer term instructional compensation unless mutually agreed to by the faculty member and the University.

Faculty development grant applications will be submitted by eligible faculty to the Dean of their college or the Director of Libraries by November 15. The Dean will in turn forward these applications along with his recommendation by January 1 to the Committee on Faculty Development which will select and notify recipients no later than February 15.

The recipient of a faculty development grant must sign a contractural agreement to return to Murray State University for a minimum of one year or shall reimburse the University for the full amount of the grant and any fringe benefit costs accompany that grant.

No later than October 1, a Faculty Development Grant recipient shall submit a written report of his grant activities to the Dean of his college and the Vice-President for Academic Programs.

The Committee on Faculty Development shall consist of one faculty member elected by the faculty of each college and the Library, one faculty member appointed by the Dean of each college and the Library, and one faculty member who shall serve as Chairman of the Committee, appointed by the Vice-President for Academic Programs.

1. Faculty Grievance Procedure

Minutes of the Meeting of the Board of Regents held on May 10, 1980, Approved

Report of the President

Dr. Curris reported that the total summer enrollment of 2927 was comparable with last summer. There was an increase in undergraduates and a decrease in graduate students. He further stated that it appears the fall enrollment will increase, that it is anticipated the freshman class will be 10% larger than last fall's class, and that with residence halls near 100% some three-to-a-room may be required.

Dr. Curris reported that the Investments Committee of the Board is responsible for investment of approximately \$2,000,000, and that the bulk of this amount is in restricted accounts such as scholarships.

The President further reported that the University and the community of Murray participated in welcoming the Visiting Committee of the Boy Scouts of America; this Committee is in the process of selecting a site for the National Boy Scout Museum. Dr. Curris expressed appreciation to Dr. Howard and Ron Christopher for their participation in the visit and stated that the target date for the Committee's decision on the site is the last of August.

Regarding capital construction projects, Dr. Curris reported that some problems are being experienced with the University Center, especially equipment money. He further stated that the University has not been able to have the moritorium on the Veterinary Diagnostic and Research Center lifted, that delays in this project will result in higher construction costs, and that delays in other projects such as roof repair are caused by red tape and are burdensome.

1979-80 unaudited Financial Report, Received

President Curris stated that through the work of Dr. Richard Gray and his staff the University now has within one month of the end of the fiscal year a report of the financial condition and that the audit report of the University will be received within four to seven months.

The Board received the attached report.

Revision of the 1980-81 University Budget, Approved

Dr. Curris stated that the University has been asked to cut back \$1.8 million for 1980-81, that the action of the 1980 General Assembly to help higher education has been negated, that this reduction in funds is especially painful because higher education has been asked to bear a major portion of the reduction in state funds, that the \$1.6 million increase approved for 1980-81 has now been offset with a reduction of \$1.8 million for 1980-81. The President asked Jim Hall, Executive Assistant to the President, to bring the Board up-to-date on the proposed revisions in the University budget necessitated by a reduction of \$1,771,800 in state funds.

In reviewing the situation, Mr. Hall stated that upon notification of the cutback, he and Dr. Curris had been in contact with the Budget Committee and that on July 28 a preliminary plan for the reduction in state appropriations had been submitted to the Secretary of Finance and the members of the Board of Regents. Mr. Hall distributed copies of a more detailed breakdown of that plan to the members.

Mr. Carneal stated that in revising the budget, the Board never considered reducing salaries that have been committed to employees.

Mr. Hall added that no action has been recommended that would jeopardize the long-term financial condition of the University and that academic travel and supplies have not been reduced.

In response to Dr. Howard's question regarding reduction in public services, Mr. Hall stated that the operating funds for the Rural Development Institute have been deleted.

Mr. West stated that cuts were painful to the faculty because of efforts made during the legislative session for additional funds to higher education and that the faculty appreciated that committed salaries would not be cut, and in response to Mr. West's inquiry, Mr. Hall affirmed that there will be faculty input on any budget reductions affecting the academic program.

Mr. Hall stated that the University will begin the process of studying the possibility of a continuing operating cut of \$750,000, and that this cut would be more difficult to absorb.

In response to Mr. Carneal's question, Mr. Hall stated that the Finance Department has given no indication that funds will be restored if the deficit in state income does not materialize, but that he believed the State is legally obligated to restore the funds.

Upon the recommendation of the Budget Committee, Mr. Carneal moved that the following 1980-81 budget reductions be approved and so reflected in the budget document.

1980/81 BUDGET REDUCTIONS

The proposed program for administering the \$1,771,800 in cutbacks for 1980-81 should be perceived as a temporary measure. Foremost in its development has been assuring that no actions will be taken that might jeopardize the long-run financial stability of the institution. In addition, the program has been designed with the objective of avoiding terminations, lay-offs, and pay reductions for existing personnel. Presently, it is reasonable to assume that both objectives will be attained.

While the 1980-81 cutback will be far from easy, coping with the \$787,200 in recurring cuts for 1981-82 (and perhaps beyond) will be even more difficult. It is not feasible to assume that such cuts can be made without personnel and program reductions. Consequently, planning for these reductions should commence immediately and should culminate with the preparation of the 1981-82 operating budget.

* * * * * * *

The following narrative details the proposed program for dealing with the 1980-81 cutback in funding.

Income: It is anticipated that the Fall, 1980 enrollment will be slightly higher than initially projected during the budget cycle. After deducting additional expenses associated with this enrollment increase, some \$100,000 in additional revenue should be available for meeting the state's mandated cutback.

<u>Position Vacancies</u>: Approximately \$231,600 will be available as a result of maintaining selected position vacancies in the academic sector of the University. Courses normally taught by faculty in these positions will be covered by either existing faculty on an in-load or over-load basis, or by hiring adjunct instructors.

Administrative position vacancies will account for about \$159,000 of the \$1.771 million in question. Particularly affected by the cutback is the initiation of the Rural Development Institute. Probably only a director will be hired during the 1980-81 fiscal year, with research staff positions being held vacant until 1981-82.

Grants in the administrative area will provide some \$48,000 in personnel savings. Fringe benefits on these grants and the anticipated position vacancies discussed above will recoup another \$43,500.

Faculty Development Grants Program: Pending Board of Regents approval the existing Summer Leave program will be replaced with a Faculty Development Grants program. Awarded on a competitive basis, these grants will enhance our faculty development activities and effect a budgetary savings for the 1980-81 fiscal year estimated to be approximately \$25,000.

Operating, Equipment and Books: Operating budget cuts in the administrative, public service, and program development areas along with equipment puchase deferrals and reductions will provide some \$284,700. No cuts are planned in the current operating budgets in the academic areas.

Approximately \$150,000 of the 1980-81 allocation for library books will be cut from the budget. Should the State's cutback be reduced or if other as yet undeterminable savings materialize, the library books budget would be a top priority for reinstatement.

The Veterinary Diagnostic and Research Center will cut some \$80,000 from its 1980-81 budget. This represents a reduction proportionally equivalent to that being made on the main campus. Likewise, the primary objective of the VDRC as it plans its reductions will be avoiding layoffs, terminations, and reductions in previously established rates of pay.

Renovation & Capital Construction Projects and Contingency Funds:

Some \$350,000 will be cut from our planned capital construction and renovation program. Many worthy projects, including several in the areas of life safety and handicapped access, will be foregone.

In addition, \$300,000 will be taken from our 1980-81 contingency fund. While there is some reluctance to expending non-recurring reserve funds, certainly the current fiscal crisis justifies such action.

Mr. McCuiston seconded and the following voted: Mr. Carneal, aye; Mr. Christopher, aye; Mr. Clark, aye; Mr. Long, aye; Mr. McCuiston, aye; Mr. Morgan, aye; Mrs. Page, aye; and Dr. Howard, aye.

Faculty Development Grant Programs, Approved

President Curris reviewed item ll of the agenda and stated it is recommended that the Board of Regents eliminate the Summer Professional Leave Program and replace said program with a competitive grants program to be known as the Faculty Professional Development Grants Program. Dr. Curris further stated this program will encourage faculty development while effecting budgetary savings and that the details of the new program will be worked out administratively with input from the Faculty Senate and the deans on the specific details.

Mrs. Page moved that the Board approve the elimination of the Summer Professional Leave Program and the establishment of the following Faculty Professional Development Grant Program.

Faculty Professional Development Grant Program

The Faculty Professional Development Grant Program is funded by the Board of Regents for the purpose of promoting the professional growth and development of its faculty in the areas of teaching, research, and public service.

The program provides summary grant awards on the basis of competitive review. Eligibility is limited to faculty who have completed eight semesters of continuous full-time academic service at Murray State University. Eight semesters of full-time academic service must be performed following previous grant awards to establish eligibility for an additional grant award.

Faculty Professional Development grants are to be utilized for approved full-time professional activities for a two-month's period (June and July). Grant awards shall be equivalent to full-time summer term instructional compensation unless mutually agreed to by the faculty member and the University.

Faculty development grant applications will be submitted by eligible faculty to the Dean of their college or the Director of Libraries by November 15. The Dean will in turn forward these applications along with his recommendation by January 1 to the Committee on Faculty Development which will select and notify recipients no later than February 15.

The recipient of a faculty development grant must sign a contractural agreement to return to Murray State University for a minimum of one year or shall reimburse the University for the full amount of the grant and any fringe benefit costs accompanying that grant.

No later than October 1, a Faculty Development Grant recipient shall submit a written report of his grant activities to the Dean of his college and the Vice-President for Academic Programs.

The Committee on Faculty Development shall consist of one faculty member elected by the faculty of each college and the Library, one faculty member appointed by the Dean of each college and the Library, and one faculty member who shall serve as Chairman of the Committee, appointed by the Vice-President for Academic Programs.

Mr. McCuiston seconded.

Mr. West supported this change in programs and expressed appreciation that the Faculty Senate will be involved in the specific details of the program.

Dr. Curris presented the proposed Faculty Grievance Procedure and reminded the members that this was a special concern of Dr. Matarazzo. He stated that long hours had gone into the development of this document and expressed appreciation to Dr. Jim Stuart, Mr. James Overby, Dr. Richard Butwell, Mr. Steve West, and the committee chaired by Dr. James Willis.

Mr. West moved that the Faculty Grievance Procedure be adopted. Mr. Long seconded.

In order to study the Procedure more thoroughly, Mr. Carneal moved that the Faculty Grievance Procedure be tabled until the next meeting. Mr. Christopher seconded and the vote to table was 8-ayes, 1-no; the Chair declared motion carried.

The Wrather Museum

Dr. Curris stated that approximately one year ago he recommended and the Board approved that Wrather Hall be retitled the Wrather Museum and that this action reflected the function of the building and respected the previous action of the Board in honoring Mr. M. O. Wrather. He further stated that some individuals are concerned that the title does not reflect the function of the building, and being mindful that the purpose of this museum is that it be considered the home of the museum of the Jackson Purchase, he suggested that the Board may wish to denote more clearly the nature of the museum by retitling it The Wrather Museum for the Jackson Purchase.

Mr. Christopher stated that he would prefer to delay in order that the Board may discuss this matter further.

It was the consensus of the Board that a committee be appointed to consider the issue; Chairman Howard appointed Mr. Christopher, Mr. Morgan, and Mr. West to study this matter.

Information

Mr. McCuiston reported that the University now has a radio sideband frequency for agriculture reports and that this service has been favorably received by the farmers.

Dr. Howard reported that one of our radio programs has been picked up nationally. Dr. Curris added that Bobby Bryant will put together a syndicated Big Band Era program from 2:00 - 4:00 p.m. on Sundays for twenty-two stations.

Mr. Morgan announced that the Alumni Association will sponsor the first Winners Circle Scholarship Program on September 6, to which all alumni scholarship winners and donars are invited to attend. He stated each regent will receive an invitation to the ceremony at 4:00 p.m. and the buffet reception following the ceremony and expressed the hope that each would attend.

Mr. Long stated that he was treasurer of the now defunct West Kentucky Productions Association, which produced the outdoor drama, "Stars in My Crown," that \$800 remained in the treasury, and that the directors of West Kentucky Productions Association have instructed him to develop a scholarship with the remaining funds. He announced that the Bob Johnson Theatrical Scholarship has been established. In response to questions regarding University matching funds, Dr. Curris stated that the Hurley matching funds had been committed, but that a check would be made to determine if any unused funds remained.

The next meeting of the Board of Regents was set for 1:00 p.m., September 6, 1980.

Meeting Adjourned
