MORTALLY SHOT BY FULTON MAN

In a Fatal Shooting Affray Labron Burton Fires Bullets into Detective Ernest Ray.

At one o'clock today in the office of the New Meadows Hotel in this city, Labron Burton, a prominent Fultonian, shot to death Ernest Ray, a bootlegging detective, who has been here for the past five weeks, secured from the Koch Secret Service Agency, of Nashville, Tenn., by the Mayors and Councils of the two Cities. The shooting was a quick sequel to the sensation spring here this morning when it was made public that nine warrants had been issued in Fulton and South Fulton for alleged illicit whiskey dealers. Burton's name, as well as the names of other well known business men, was in the list.

When the fatal duel took place in the crowded office of the Meadows, where a half dozen or more traveling men lingered for after-dinner chat, a bomb shell dropped into the center of the room from the hand of an anarchist could not have created more tremendous excitement, for as the shots rang out without a moment's warning, the smoke-filled room was the scene of indescribable confusion.

Ray's prostrate form on the floor with his intestines perforated with deadly bullets. Burton immediately after the shooting went to his livery stable in South Fulton, where he gave up to Policeman DeMent Weaver. He stated at once that he would return to Kentucky soil without requisition, and retained Robbins, Thomas, Carr and Carr, and Ed Thomas as his lawyers. He refused to return to this side until he had conferred with his lawyers.

The Leader man interviewed Mr. Burton at his South Fulton livery stable within a few minutes after the tragedy and the latter's statement is given verbatim: "I learned this morning that a warrant had been issued for my arrest for bootlegging and shortly afterwards was arrested by Policeman Weaver in South Fulton."

charged with two offenses. When I asked who was the prosecutor I was told that a man named Ray swore he bought whiskey of me. I went to seek this man, whom I did not know, to ask him about the matter, since I had never sold him or any other man any whiskey. I was told by several that Ray was at the Meadows Hotel and I went up there to look for him. I entered the office, where a number of men were standing around and asked a young fellow if his name was Ray. 'No,' he said, 'but there is Mr. Ray standing over there.' The man he pointed out was at the register and I went up to him and asked for his name Ray. 'Yes,' he said, and ran his hand back towards his hip pocket. I didn't think about his having a pistol, but thought he was going to strike me with the hand drawn back, so I struck him on the head with a stick I carried. By this time Ray had drawn his gun and fired at me, fired back several times; I do not know how many times. Ray fell and I walked through the stairs and came over here to shoot Ray in self defense."

The following statement was given The Leader by O. O. Laster, a well known traveling man of Water Valley, Ky. Mr. Laster was an eye witness of the whole occurrence and the one shot which Ray fired missed his head little more than an inch, smashing the window in front of which Laster sat:

"I was sitting right here when the shooting took place. Burton came in while Ray was standing at the register and asked him if his name was Ray. Ray replied that it was and Burton said something about bootlegging and at the same time struck Ray with a stick which he carried. A moment later I saw the guns flashing and felt the whistle of a bullet by my ear. Ray fell to the floor and moaned 'Oh! Oh!' several times, while Burton walked away. It seemed to me that Burton fired the first shot."

The following statement was made by Ray himself, who, believing himself to be dying, desired to tell his version of the affair. It was made in the presence of several witnesses:

"I was standing at the hotel register right after dinner and had picked up the telephone receiver, ixing to call up the Mayor. Some one touched me and asked me from behind if my name was Ray. I said it was and was struck on the side of the head as I turned round and at the same time some one began shooting at me. I saw that it was Labron Burton. He shot me several times in the body and as I fell I fired one shot at him which didn't seem to come near him. After I had fallen he pointed his gun at me as if he was going to shoot again, but he then disappeared in an adjoining room. He did all his shooting before I had time to fire. Mayor

Swann told Burton a few minutes before the shooting that I had told the South Fulton officers that he was selling whiskey."

The wounded man will die. One bullet passed from side to side through his stomach and bowels, while one bullet entered the small of his back and came out below the navel. A third bullet was buried in a pocketbook full of papers in Ray's hip pocket. This bullet never entered the skin. The wounded man was hurried to Memphis this afternoon for an operation. Train No. 105 stopped at the Main street crossing and Ray was placed in the baggage car.

Sirl Baker, Ray's running mate, was with him when the shooting took place but did not participate in the fight. Both he and Ray were secured by the councils of Fulton and South Fulton from Nashville before Christmas and have been at work here ever since. Today's arrests were the results of about five weeks sleuthing.

It is needless to say that the excitement runs high in Fulton in regard to the fatal shooting affray. Nothing else is being talked of anywhere upon the streets.

SAW LINCOLN KILLED

Noted Actress Coming.

One of the most remarkable women on the American stage today is Mrs. Katharine M. Evans, who celebrated her fiftieth year behind the footlights recently and who played the part of Sharpe in "Our American Cousin," at Ford Theatre, Washington, D. C., the night of the assassination of President Lincoln, April 14th, 1865, which is now over forty-four years ago.

She tells of that awful night how the shot was heard, most of the audience thinking it was part of the play at first. How Booth jumped from the presidential box, caught his spur in the flag that draped it and fell on the stage, breaking his leg. Then the vast audience, rose in a body, rushed over seats forgetting their companions, realizing what happened, amid ladies screaming who knew not what to do. The stage was filled with actors and actresses with their makeups on in a moment and citizens clamoring for the assassin who escaped by way of the back door, mounted his horse in waiting and got away, but later was captured. Mrs. Evans has always been an ardent admirer of President Lincoln, having played before him on several occasions, and is today at her age one of the jolliest members of the Lyman Twins Company and the mother of the show.

Messrs. Slayden and Morgan declare that they were legally elected to the offices and that they have nothing more to do with the elections which have been held since the first election and those to follow. If the matter is not settled at an early date it would not be at all improbable that it be taken to the courts.

HERE IS HAWAIIAN DELICACY

Sweet Potato Dish That Is Worthy of a Place on American Tables.

The Hawaiians make a unique sweet potato dish and call it koele palan. Mash some fresh boiled sweet potatoes, reheat them in a cocoanut cream which is given below, and serve hot.

For the cream, grate a cocoanut, heat it slowly in half pint of milk. When the boiling point is reached strain it through a bag. Squeeze the bag thoroughly to extract as much of the flavor and juice as possible, and it will be ready for use. The "cream," if preferred, need not be strained, but simply poured over the mashed potato and mixed through it. Add a large spoonful of butter and let the mixture become very hot and then serve. If the mixture is formed into cakes and fried brown in butter it will make a novel and delicious dish at luncheon or whenever croquettes are appropriate. Use the ingredients in proportions to suit the taste. The cocoanut cream just mentioned is also used by Hawaiians with bananas in a pudding and in various other dishes.

TRY THESE "BREAD BOXES"

Idea That Will Be Something of a Novelty to Many of Our Readers.

"Bread boxes" are an artistic, cheap and delicious way to serve many entrees, as eggs, chestnuts or greens. They are easy to make but comparatively few women understand it.

Cut stale bread, at least two days old, in four-inch cubes, having first removed crusts.

Dip each cube into slightly beaten egg and fry in boiling lard, in a frying basket. Remove when golden brown and drain on brown paper.

Cut out a square from one side of the cube a quarter of an inch smaller than the box and dig out the crumb, leaving the sides and bottom about a half-inch thick.

Before using set the "bread boxes" in a hot oven to heat through, fill with whatever mixture is desired and add the lid or not as preferred.

Curried Apples.

A dish to serve with pork chops is made of thin slices of apples and onions fried together in butter, with a sprinkling of curry powder as seasoning. A recipe similar to that just given is a foreign one called Madras curried apples. Peel and core four sour apples. Cut them in rings. Sprinkle with a little curry powder, and fry till brown, adding as they cook a few shallots cut in thin slices. Cover the mixture and let it cook until done. Serve on a platter with boiled rice and a curry sauce.

For a curry sauce use a white sauce flavored with curry or a drawn butter or black butter sauce flavored in the same way and prepared from the drippings in the pan.

A Dainty with Tea.

A nice little dainty to serve with afternoon tea or a cup of chocolate or coffee is composed of crackers covered with sugared nuts. Any kind of thin cracker may be used, some persons preferring a slightly sweetened wafer, others liking a thin cracker or salted wafer. For the mixture stir together a cupful of confectioner's sugar, a quarter of a cupful of chopped nuts and a quarter of a cupful of cream, lastly whip in the white of an egg beaten to a stiff froth. Spread a spoonful of this mixture in center of the cracker and brown in a quick oven.

Apricot Souffle.

Put six ripe apricots into a saucepan, add a quarter-pound of sugar and a quarter of a pint of water; stir till cooked; rub through a sieve and lay aside. Blend two tablespoonfuls of flour with one heaping tablespoonful of butter in a saucepan over the fire, gradually add one gill of milk; stir till it boils, then add the apricot puree and boil again for eight minutes.

Remove the saucepan from the fire, add the yolks of three eggs one by one, then the whites of four eggs beaten up very stiffly. Pour into a buttered mold and bake in a moderate oven for 30 minutes. Serve at once.

Plain Orange Salad.

Housekeepers who are canny in other directions too often forget that a heavy salad is out of place at the dinner table. Plain orange salad served with French dressing on lettuce leaves cannot be improved upon for most persons by any admixture. Diced pineapple with orange is always delicious, and for variety peaches or pears may be added. Large, ripe alligator pears, at their best now in the fancy fruit shops, are one of the possibilities.

Orange Walnut Candy.

White one egg, juice one orange, slight grating orange rind, one cup English walnut meats, confectioner's sugar. Beat the egg slightly, add the orange juice and rind, the nut meats broken in pieces and enough sugar to stiffen. Knead, roll out and cut into small squares.

Cornmeal Puffs.

Into a double boiler put 1 quart of milk. When scalding hot stir in 8 tablespoonfuls of yellow corn meal, 4 of sugar and a teaspoon of salt. Cook 30 minutes and when cool stir in 4 eggs. Yolks and whites beaten separately. Pour into buttered cups and bake 30 minutes.

Home-Made Cider.

Wash, wipe dry, and quarter apples. Put through meat chopper, using the finest knife. Place in muslin bag and put in a fruit presser.
