MINUTES OF THE BOARD OF REGENTSMURRAY STATE NORMAL SCHOOL AND TEACHERS COLLEGE

July 30, 1928

The Board of Regents of the Murray State Normal School and Teachers College met in the Science Laboratory of the Training School Building, Monday, July 30, 1928, with the following members present: Mr. G. P. Thomas, Mr. J. F. Wilson, Mrs. William H. Mason and Mr. G. P. Ordway.

Mr. E. E. Shannon, Chairman of the State Purchasing Commission, met with the Board of Regents and submitted bids which he had received in his office for laboratory equipment for the Training School Building.

Bids for Laboratory Equipment for Training School

Bids were submitted by Kewaunee Mfg. Co. and E. H. Sheldon Co., for domestic science, biology, chemistry, physics and art equipment for the training school, as f. o. b. Murray, Kentucky, as follows:
