August 23, 1929

Commencement Exercises

The Board of Regents adjourned to the Auditorium Building to participate in the Commencement Exercises, the closing of the summer school, to reconvene at 1:00 o'clock in the President's office.

Vice Chairman G. P. Thomas Arrived

When the Board reconvened at 1:00 o'clock Mr. G. P. Thomas was present and remained through the afternoon session.

Election of Additional Faculty

President Wells recommended that the following persons be elected members of the faculty at the salaries stated, for the period beginning September 15, 1929 and closing May 31, 1930:

Miss Lida Muse at \$2,800.00 per calendar year
Mr. J. W. Compton at \$3,000.00 per calendar year

Motion was made by Mr. Ordway, and seconded by Mrs. Mason, that the above named persons be elected members of the faculty for the period of time and at the salaries recommended. The roll was called upon the adoption of this motion with the following result: Mr. Wilson, aye; Mr. Thomas, aye; Mrs. Mason, aye; Mr. Ordway, aye.

Roof of Auditorium

After some discussion of the condition of the roof on the Auditorium, Mrs. Mason made a motion which was seconded by Mr. Wilson, that the President be authorized to have the roof repaired. The roll was called upon the adoption of this motion with the following result: Mr. Wilson, aye; Mr. Thomas, aye; Mrs. Mason, aye; Mr. Ordway, aye.

Upon the suggestion of President Wells that some member of the Board inspect the roof and see what was needed to be done to it, Mr. Wilson was named to act with Mr. Wells as a Committee to inspect the roof of the Auditorium and decide what is necessary to properly repair it.

Elevator for Wells Hall

After discussion of the need for an elevator in Wells Hall, it was agreed that President Wells should write some companies and ascertain the cost of installing an elevator.

Vault

There was considerable discussion about the proper location, the size, and plans and specifications for a vault for the Registrar's office.


Mr. Wilson made a motion, which was seconded by Mr. Ordway, that Mr. C. H. Lockett be instructed to draw plans and specifications for a vault, on the basis of two per cent of the contract price, with the privilege of bidding on the installation of the vault, and that these plans and specifications be presented to the Board of Regents for discussion on August 29, 1929. The roll call upon the adoption of this motion showed the following result: Mr. Wilson, aye; Mr. Thomas, aye; Mrs. Mason, aye; Mr. Ordway, aye.

*Certificate of Roberta Jones

It appears from the minutes of August 10, 1928 that Miss Roberta Jones was recommended for extension of her standard certificate for life and that, after this recommendation was made, it was discovered that three years had not elapsed since the certificate was issued. For that reason, it was thought advisable to wait until the expiration of the three years before the certificate should be renewed for life, and the Committee recommends for action and approval of the Board of Regents on this date, that said certificate be now extended for life and that extension of August 10, 1928 be cancelled and that the extension date from this date.

Adjournment

Motion was made by Mr. Wilson, and seconded by Mr. Thomas, that the Board adjourn to meet again Thursday, August 29, 1929. The roll was called upon the adoption of this motion with all members voting, "Aye".
