MINUTES OF BOARD OF REGENTSMURRAY STATE NORMAL SCHOOL AND TEACHERS COLLEGE

March 12, 1930

The Board of Regents of the Murray State Normal School and Teachers College met in the office of the President Wednesday, March 12, 1930, with the following members present: Mr. J. F. Wilson, Mrs. William H. Mason, Mr. G. P. Ordway and Mr. G. P. Thomas.

Reading of the Minutes

The minutes of the meeting of the Board of Regents on October 3, 1929, October 29, 1929, November 30, 1929, December 20, 1929 and February 24, 1930 were read.

Motion was made by Mrs. Mason, and seconded by Mr. Ordway, that the minutes be approved as read. This motion was unanimously carried.

Report of Entrance, Credits, Certification and Graduation Committee

President Wells presented the report of the Committee on Entrance, Credits, Certification and Graduation and recommended that the certificates be issued and renewed according to the following recommendations:

Motion was made by Mr. Ordway, and seconded by Mrs. Mason, that the report of the Committee on Entrance, Credits, Certification and Graduation be accepted and the certificates issued and renewed as recommended. This motion was unanimously carried.

Bills Passed by General Assembly Affecting this Institution

President Wells reported to the Board of Regents that the General Assembly has passed a bill, during its present session, which provides for an appropriation to this institution of \$125,000.00 annually, during the next bi-ennial period, to be used in a building program. He also reported that the new Certification law provides that students who do not desire to prepare themselves for the teaching profession, may take a liberal arts course and earn a degree from this institution without being required to complete the courses in education subjects which are required in order to secure a certificate to teach. He stated that another provision of the Certification law eliminates the name, "Normal School" from the title of the four state educational institutions and they are now legally styled as State Teachers Colleges. President Wells also stated that the General Assembly has passed an Equalization bill, under the provisions of which school teachers will receive a minimum salary of \$75.00 per month.

Plans and Specifications for New Buildings

Architect G. Tandy Smith, Jr., was called before the Board for a discussion of the plans and specifications for the new buildings. These matters were discussed at some length but no definite action was taken.

Adjournment

Motion was made, seconded and carried that the Board adjourn to meet again at one o'clock Friday afternoon, March 14, 1930.
