THE LISTENING POST

● I saw something the other night which has kept me puzzled ever since, and I have never been able to figure out exactly just what the arrangement was. I am still mulling over the matter, and if I find the solution I'll be letting you know. Thus far the solution has eluded me, despite intensive study and consultation with other master minds. To begin, let me say, to avoid any useless questions or any embarrassment to any person, I knew none of the parties involved. 250,000 Seek To Enter U. S. From Germany

Jewish Applicants Total 85 Per Cent Of Applications

Washington, —More than 250,000 Germans, officials indicated tonight, are trying to get into the United States.

On October 1, last date for which exact figures are available, there were 220,000 would-be immigrants on the waiting list. It was officially calculated that at least 85 per cent of them were Jews.

U. S. Consulate Besieged
Indications were that the latest outbreak of Nazi anti-Semitism had sent the figure beyond a quarter million. Cables from Berlin said the American Consulate was stormed by frantic wives of arrested persons, seeking credentials permitting their husbands to enter the United States. Such papers in the past have enabled some Jews to regain freedom.

Judge Bowman Is Principal Speaker

Jules Bowman, Louisville insurance man, was the principal speaker today before a joint meeting of the Rotary Club, Lions Club, Chamber of Commerce and the Young Men's Business Club, which was held in connection with a survey made here today by the Fire Prevention Association of Kentucky. About 80 persons were present, including a number of fire insurance men from various sections of the state.

Leon Browder presided over the meeting and Joe Davis gave a brief address of welcome. Mr. Bowman, in his talk, outlined the different phases of the insurance business and told of the inception of fire prevention work. Urging that every effort be made to eliminate needless fire hazard, he stated that the business men and the insurance men should work hand in hand to reduce fire losses.

An inspection was made of business establishments in Fulton during the day and a report will be made of this survey at a later date.

Adelanto, Calif., —An 82-year-old woman who fought Indians in the early days of the West, held a decision today over a 35-year-old intruder who broke into her house in the Mojave Desert community.

Sheriff Emmett L. Shay said Elizabeth Christine Albertson surprised Arthur Fiola when she returned home from a walk, and that Fiola confessed he was hiding behind a door and intended to rob the woman. She bit Fiola on the hand, almost severing a finger, and pemmeled him so severely he fled.

Judge Decides Closed Eyes Don't Make Nap

Nashville, Tenn., —Shut eyes don't make a nap, G. B. Curtis convinced a Criminal Court judge today.

Curtis was a member of a jury which returned a conviction in a larceny case last week. Defense counsel asked a mistrial, asserting the 84-year-old juror slept through the court's charge.

The Prosecutor granted Curtis' eyes might have been shut, but said that didn't mean he was asleep. So Curtis was brought to the stand today and convinced the judge he had heard everything that was said. The mistrial was denied.

Sees Virtual Moral Quarantine Of Germany By U. S. Over Jews

Washington, —A virtual moral quarantine of Nazi Germany by the United States because of harsh anti-Jewish measures in the Reich appears to be a possibility now that Ambassador Hugh R. Wilson has been called home from Berlin.

While Wilson was summoned nominally to report and consult the implications of a potential severance of diplomatic relations with Germany in direct humanitarian protest are so strong as to suggest to observers that Washington is inviting other nations, particularly those of the Pan-American family, to follow suit.

The imminence of the Pan-American Conference at Lima, Peru, where the tension between Washington and Berlin is likely to be discussed along with the "Good Neighbor" purposes of the United States rearmament program, adds to the impression that Wilson's orders are traceable to far-reaching motives of national policy.

President Roosevelt's selection of his 1938 Republican rival for the Presidency, Alfred M. Landon of

Kansas, for service on the American delegation at Lima, had already emphasized his hope of showing to the world, particularly to Germany, that whatever discord in this country over domestic policies Berlin may read into returns of the recent national elections, it does not apply to major foreign policy.

During the American election campaign there was virtually no debate over the President's announced proposal of proposed rearmament of a gigantic scale. That was read as insuring non-partisan support for the program in Congress, whatever wrangling may develop over its details and financing.

On top of that has now come a national reaction to the German measures against Jews. In order to the impression that Wilson's here and abroad that the move is a virtual blacklisting of Germany in a diplomatic sense, Washington is apparently urging action, not words of protest alone.

Murder Plot Admitted By Hired Man

Hamilton, Ala., —A jury trying Dr. Reuben B. Barnes heard a former hired man testify today the invalid physician plotted with him to slay Mrs. Barnes last March 13.

Dr. Barnes, bed-ridden for years, is accused of hiring Brad Byars, his former body servant, to shoot Mrs. Barnes at Winfield, Ala., after learning she had been intimate with Byars.

To Testify From Cot
Following Byars' testimony, J. M. Pennington, defense counsel, said Dr. Barnes would be called to the stand probably tomorrow. The physician will testify from an ambulance cot.

Byars, now under life sentence for shooting Mrs. Barnes, testified plans to slay the woman were worked out after he and Mrs. Barnes confessed their intimacies to the doctor.

During more than three hours on the witness stand, Byars testified Dr. Barnes gave him medicine containing opiates to "steady his nerves" before he shot the 42-year-old woman.

Asked if he killed Mrs. Barnes, Byars lowered his head and answered "yes."

Work on the new overhead bridge on State Line will start Monday morning, it was learned today, and will be pushed as rapidly as possible. The contractor who has the project has already moved to Fulton and is now getting ready to start actual construction.

Mother Seeks To Save Son From Chair

Washington, —The mother of James Dalhove, Brady gang member who is to be electrocuted Friday, sought executive clemency in the Capital today to save her son from the disgrace of death in the chair.

The mother, Mrs. Bertha D. Craig of Madison, Ind., said she had little hope for a pardon. If her son does have to die, she said, she wanted to help him realize his desire to be infected with deadly germs in the interest of science.

Accompanied by her attorney, Mansel Hagerty of South Bend, Ind., she tried unsuccessfully to see President Roosevelt and Attorney General Cummings, and finally presented her plea to Daniel M. Lyons, pardon attorney of the department.

Lyons will present the facts to the Attorney General, who has the authority to make a recommendation to President Roosevelt. Only the Chief Executive can act in a capital offense case.

Dalhove was convicted of the murder of a policeman. He is held at the Milan detention farm, but the execution is to be in the Michigan City, Ind., State prison.

Population Of U. S. At High Of 130,215,000

Washington, —The census bureau announced today that preliminary estimates indicated a record population of 130,215,000 for continental United States on July 1, 1938.

The total represented a population increase of 958,000 over the 1937 estimate.

The estimates were based on the number of births and deaths during the year ended June 30, 1938, and the excess of immigration over emigration.

The excess of births over deaths was estimated at approximately 918,000 and net immigration at approximately 43,000.

Court Decides In Favor Of Judge Adams

On yesterday, a motion was made before Judge L. L. Hindman, Judge of the Fulton Circuit Court at Clinton, Kentucky for the reduction of the bail of Aaron Dinwiddie, who was given an examining trial before Judge Lon Adams in the Fulton Police Court on October 4, 1938 on a charge of knowingly receiving stolen property, and he was held over to await the action of the grand jury on a bond of \$750.00. Failing to make bond he was carried to the county jail.

As heretofore stated, Judge Walker, within some two or three days after Dinwiddie was placed in jail, had him brought before him and reduced the bail from \$750.00 to \$300.00 and accepted T. J. Sapp, colored undertaker of South Fulton, on the bond and released the prisoner from jail. Judge Adams immediately, upon learning that the prisoner had been released, issued a capias and had the negro rearrested and recommitted to jail, after which the negro sued out a writ of habeas corpus before Judge Walker, seeking by that means to get himself released. When Judge Adams learned that that move had been made, he obtained a writ of prohibition in the Fulton Circuit Court to restrain Judge Walker from proceeding with the writ of habeas corpus, and that writ of prohibition was tried before Judge Hindman several days ago and the court sustained the contention of Judge Adams and issued a restraining order, restraining and prohibiting Walker from trying the writ of habeas corpus. As a final move the negro, Dinwiddie, made a motion on yesterday as above stated, before Judge Hindman for the reduction of the bail.

The matter was submitted to Judge Hindman upon an agreed state of facts and after argument, the council of the court decided that the bail of \$750.00, as fixed by Judge Adams in the original trial, was not accessible, and overruled Dinwiddie's motion for reduction of bail.

Maryland Lowers Flag As Tribute To Dead Newsboy

Annapolis, Md., —The State of Maryland will pay tribute tomorrow to a newsboy who sold his wares for sixty-nine years in the Statehouse, extended credit for hot-dogs to legislators and was often elected president of the Legislature at its "fun sessions."

Gov. Harry W. Nice said the flag atop the Statehouse will be lowered to half mast tomorrow when W. H. (Snake) Baker is buried.

The 75-year-old newsboy couldn't read the headlines because he left school when 6, but he could sell them. There might be wars in Europe and catastrophes in the United States, but Baker sold his papers to Legislators by shouting: "Latest Paper—your name is in it."

Whiff Of Medicinal "Snuff" Is Recommended For Ulcers

Oklahoma City, —A whiff of medicinal "snuff" was reported today as the newest and most successful treatment of stomach ulcers, one of the commonest complaints of fast-living civilized man. The "snuff" treatment, announced to the Southern Medical Association by Dr. M. Hill Metz and Dr. Robert W. Lackey of Baylor University, Dallas, has been found effective in 55 out of 60 cases on which it was tried.

A finely-ground powder made from the rear half of the pituitary glands of animals is the special "snuff" used, they said. It is inhaled into the nose. The pituitary gland, which is divided into fore and aft parts, is located just at the base of the brain and is the master gland of the body, controlling the hormone secretions of all

German Press Says Menace Is Imaginary

Claims Roosevelt Using As An Excuse To Arm Nation

Berlin, —Adolf Hitler's Voelischer Beobachter in captions today said President Roosevelt in his White House press conference pictured an imaginary menace to America to further an armaments program.

"Roosevelt's imaginary 'menace' to America," the caption read in one of the few German morning papers to print a brief account of Tuesday's interview. "Suspicious cast on other powers in the interest of United States armaments."

It was the first reaction printed in Germany to the United States President's announcement that air force plans contemplated defense of both North and South America. Yesterday was a Protestant holiday, the day of atonement, and most government officials were en route to Dusseldorf for the funeral of Ernst Vom Rath, slain diplomat.

German Jews, most of them in seclusion and an estimated 40,000 under arrest, last night fearfully awaited their ultimate fate.

These were immediate factors in their fears and hopes:

1.—The funeral tomorrow of a Nazi diplomat whose assassination by a young Jew in Paris last week started the latest wave of anti-Semitic violence and repressive decrees.

2.—A United States protest on behalf of American Jews following President Roosevelt's denunciation of anti-Jewish actions.

3.—The suspension of normal government business today because of the Protestant day of atonement. Resignedly, the Jews believed the government would use the funeral of Ernst Vom Rath as an occasion to issue further restrictions promised by Field Marshal Goebbels. Some Jews professed to have received a warning—in what they did not explain—that another "spontaneous demonstration" such as last Thursday's might be organized in connection with services for Vom Rath, a secretary of the German embassy in Paris slain by the 17-year-old Herchel Grynszpan.

SHUTTING OUT HATE

Americans are weighing Representative Martin Dies' charges that the New Deal Administration has opposed and tried to hamper his committee investigation of un-American activities against the judgment of many observers that the committee's procedure has been singularly unjudicial, open to character assassination and political harpooning. One upshot must be to raise an inquiry as to just what kind of legislation if any, the Dies committee has in view to propose.

It was recently pointed out by Walter Lippmann in connection with the case of John Strachey, who still seeks entry as a visiting lecturer, that the statute involved is one prepared nearly twenty years ago, hardly applicable with exactitude to the ideologies which threaten democracy today. It forbids admission of aliens who teach "the overthrow by force or violence of the Government of the United States or all forms of law." The platform of the Communist Party in the United States does not call for use of force, and a Communist or Fascist from without might readily declare that he favors, in theory at least, the use of the ballot to obtain a legal majority.

But so long as even radical activity remains in the realm of argument and persuasion it will be boomerang democracy to move against it with force or be the first to resort to violence. Not only is this inconsistent with the democratic tradition to expect to find notions out of men's heads with nightsticks, but such attempts at suppression are in the long run ineffective. A weak cause may thrive on martyrdom. Justice is the best antidote for dissent.

Judge William Clark appropriately emphasized this in his decision last week enjoining Mayor Frank Hague from interfering with the right of free speech on the part of CIO organizers in Jersey City. A quarantine, he remarked, may apply in the field of physical science, but ideas are not "Japanese beetles," to be stopped by such means. Under the American Constitution, he declares, neither a city, a state nor the Nation may banish a citizen even after due trial, and the Nation may deport an undesirable alien only on grounds and after a hearing.

But what if the Communist or Fascist should appeal to force? In the first place, neither of these groups is likely to do so unless it is a large enough minority to see a prospect of success at arms, and in the second place, any such turn

would be preceded by a number of manifestations partaking of the nature of force. These include the maintenance of private armies, wearing of insignia which stand for violent methods and the use of parades, or propaganda to incite riots.

Some such safeguards may be necessary, according to the rule of meeting reason with reason but holding force in check with the power of the State. Before any such point is reached, however, the far more important consideration is to root out of the human mentality the hate and intolerance that would try to delude a nation into thinking it must divide into hostile camps or that a Government for the general welfare can be built on the suppression of liberties.

For essentially it is hatred that leads to violence and it is intolerance that believe it can brook no opposition. When men dwell together in unity as to national ideal and the greater good of mankind they can profit by the exchange of thought and judgment in composing their lesser differences of human method. Laws proposed to combat un-American activities should not depart from this basic American spirit. —Christian Science Monitor.

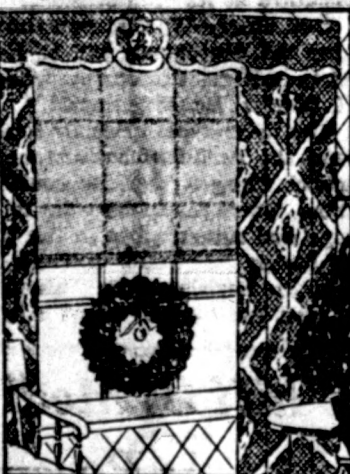

Hints for Homemakers

FALL and winter holidays are just around the corner. That means guests for dinner, children home from school, parties for them and in general, open house.

You will no doubt redecorate your home with fresh curtains and draperies, but we'd suggest you begin this process from the bottom and start with fresh cloth window shades.

Harmonize your window shades with the gaiety of the holiday season; get that rich warm tone called chrysanthemum yellow, or sunrose; both brighten your rooms and actually seem to bring the sunshine indoors on dull days, for both these colors reflect light.

If you want to keep your home snug and warm hang two cloth window shades at every window, for two shades conserve as much as 43% possible heat loss. It is well to select a decorative color for the inside room; such as turquoise blue, springleaf green, chrysanthemum yellow and sunrose. Then choose conservative white or cream for the shades next to the glass and thus present a uniform appearance to the street. The whole effect is of course very apt and span.

Irwin Pleads Guilty, Accepts Life Term For Triple Slaying

New York. —Robert Irwin, the "mad sculptor" who killed a mother and beautiful daughter and their apartment boarder on Easter morn., 1937, today accepted—but protesting gibberishly—a life in prison rather than the possibility of death in the electric chair.

The 31-year-old one-time divinity student and erstwhile asylum inmate abruptly was pleaded guilty to second degree murder before completion of a jury to try him on first degree charges.

Irwin, himself protested almost incoherently but finally yielded when the judge asked for a forthright plea.

A thin, wasted figure ravaged by disease and weighing about 120 pounds, he shouted at first that he did not consider himself guilty of murder.

"I looked it up in the dictionary," he screamed, "and it said murder was the malicious killing of one person by another. There was nothing malicious in what I did."

"I am pleading against my better judgment and only to save money," he said.

Pressed by Judge James G. Wallace for an unqualified plea, he assented, mumbling, after wheedling to accuse his guards of "abominable" treatment.

Irwin's victims were Veronica Gedeon, pretty young photographer's model; her mother, and Frank

Byrne, all slain in the early morning in a rage of twisted jealousy over Irwin's thwarted suit to win the affection of Veronica's sister, who married another.

The crime shocked the normal calm of Easteride on Beekman Hill, where the Gedeons lived modestly on the fringe of wealth in the Middle East Side of Manhattan.

District Attorney Thomas E. Dewey said he would recommend a sentence of 90 years to life for each of the three murders and that they should be served consecutively.

"It is imperative," Dewey said, "that the community be permanently protected against Irwin's possible return to society. This man has been previously committed as insane five times."

"Had the case gone to the jury, Irwin might have been held legally insane at the time the murders were committed and then could have been released on the community again. Now that will never happen."

Frankfort, Ky.—The State Treasury began making out checks today to pay for the schools and aged indigents.

The school money, representing \$12.12 for each pupil, to help pay teachers' salaries, totaled \$1,472,297 for the November payment. The old-age pensions, of which the Federal Government put up half, amounted to \$384,968. That represented November pensions of \$5 to \$15 each for 42,940 persons over 65 years of age.

Man 30 Years A Fugitive Asks Pardon

Williamson, W. Va.—Without surrendering the freedom gained more than thirty years ago by escape from an insane asylum, Sampson Kennedy, alias Kennedy, is seeking pardon or commutation of a life sentence for murder.

In January, 1899, Canada was sentenced to life for the killing of Harrison Steele, member of a prominent family.

The case was brought out of the dust of years today by publication of a notice, through relatives, that Canada would ask Gov. Homer A. Holt for a parole or commutation.

Canada's whereabouts remained undisclosed.

After a few years in prison, he was transferred to Spencer State Hospital, from which he escaped in 1908. Relatives related that Canada embraced religion and has led an exemplary life.

Steele was shot to death near Devon in 1898.

Most of the principals in the tragedy are dead.

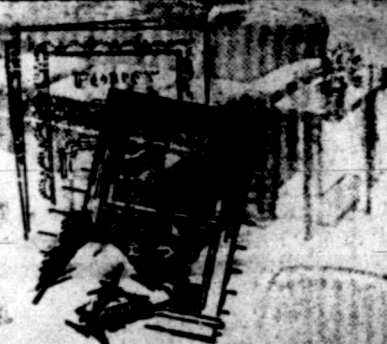

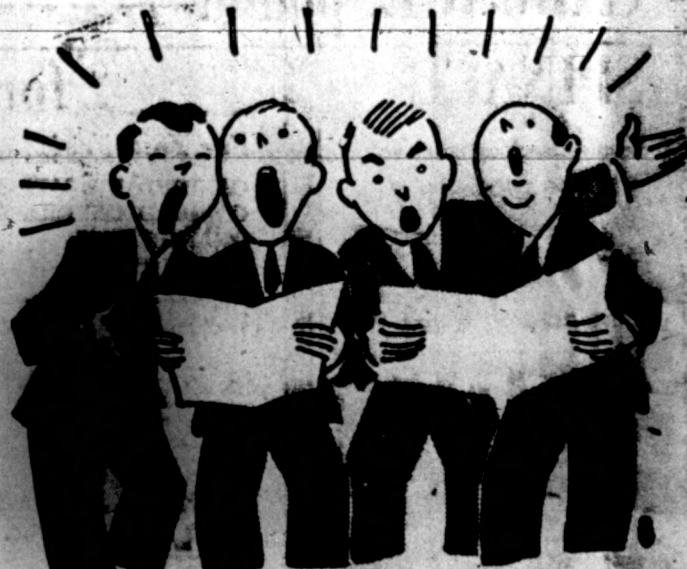

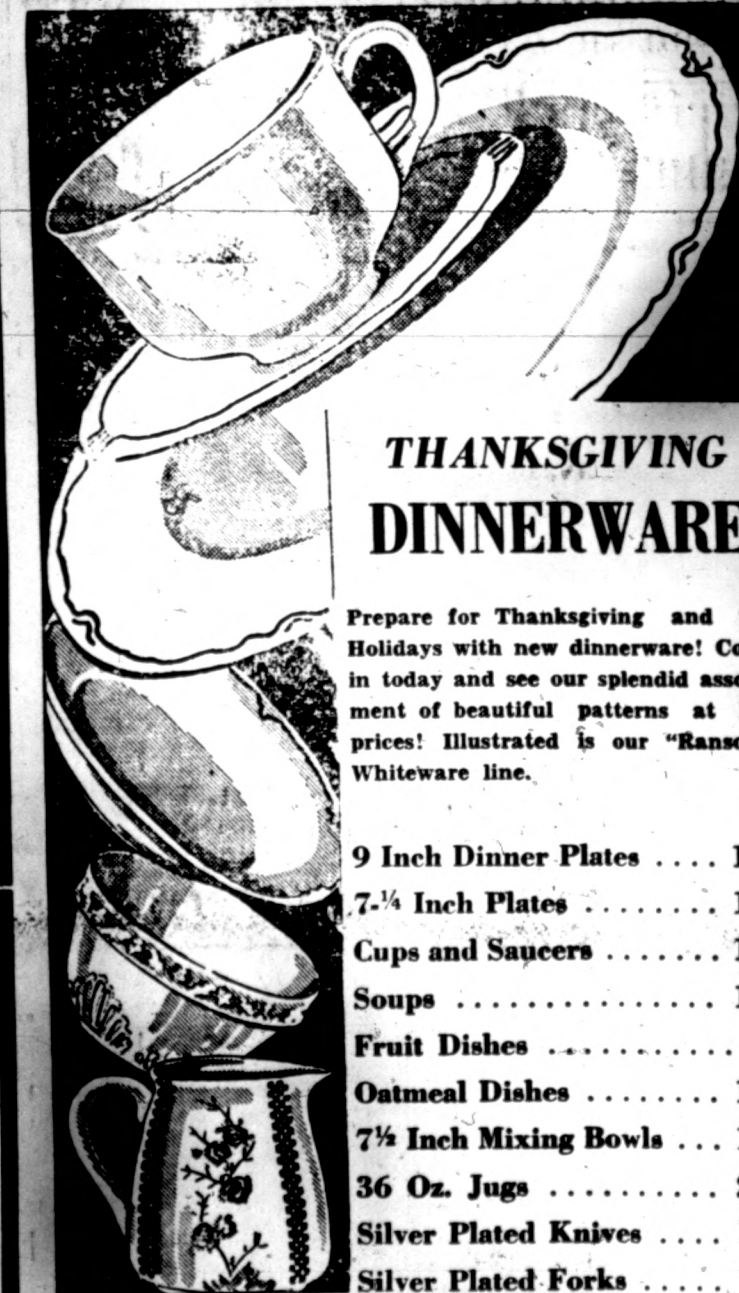
