EARLEY PETTIE

Indicted for the Murder of His Father and Trial Was Had Thursday of this Week.

Earley Pettie, who some several weeks ago shot and killed his father, T. F. Pettie, of the Gunters Flat section of the county, was indicted by the grand jury last week for murder and his trial set for Thursday of this week. The fate of the youth is now in the hands of the jury and a verdict is expected at any time. Large crowds attended the trial and great interest has been manifested by those attending.

Quite a number of cases have been disposed of the past week in circuit court. Raymond Vandike, colored, was convicted of voluntary manslaughter and will serve from 5 to 21 years in the penitentiary for his crime. He shot and killed John Gardner, also colored, some several months ago.

The grand jury finished its labors the first of this week and was discharged. A total of 15 indictments were returned as follows:

G. C. James, six charges for forgery and obtaining money under false pretense. James was arrested and bond fixed in each case at \$300. He was unable to secure bond and was ordered to jail. Irvan Forrest and Noble Wilson were indicted for assault with intent to kill. They executed bond. The N. C. & St. L. railway was indicted in 11 cases for delivering liquor to an improper person. Levi Pettie, colored, who shot his sweetheart some few weeks ago and afterwards attempted suicide was indicted for malicious shooting. Other indictments were two for detaining a woman against her will; two for liquor selling; three for forgery; one for selling deadly weapon; one for house breaking; three carrying deadly weapon; one for drunkenness; one escaping jail; one breach of the peace.

The suit of Carsey & Co., warehousemen of Clarksville, against J. B. Swann, growing out of money advanced on association tobacco, was heard by Judge Hanberry Wednesday.

The case of Levi Pettie, colored, was called Friday morning and the evidence is now being heard.

Gilbert is Acquitted.

The following from the Paducah News Democrat of the 17th will be read with pleasure by many Calloway friends of the well known young attorney: Attorney M. E. Gilbert, a member of the Paducah Bar association, indicted at the last April term of circuit court by a McCracken county grand jury for grand larceny and knowingly receiving stolen property. Thursday afternoon at 3:30 o'clock

was acquitted by a jury, which, after an hour's deliberation, returned a verdict of "not guilty." Mr. Gilbert expressed himself as grateful for the verdict and thanked each juror as he fervently shook their hands.

The Gilbert case attracted more or less attention because of the prominence of the defendant. The charge entered against the young attorney grew out of the theft and reappearance in Mr. Gilbert's office of the law books shipped from Fulton, Ky., to Attorney James C. Cheek, of this city. It was charged in the indictment that Gilbert had either obtained the books knowing them to be stolen property or had stolen them himself. All evidence introduced by the prosecution was of entirely a circumstantial nature, and Commonwealth's Attorney John G. Lovett following the trial admitted that the prosecution had made out a weak case against the lawyer.

Nearly Ten Thousand Hogsheads Sold.

The county committee of the Planters Protective Association met Monday morning in the court house. The committee ordered that suit be filed against Allen Richardson, a negro living in the Torian precinct, for selling his tobacco outside the Association after he had pledged his crop to the Association.

J. W. Usher reported to the committee that the Association had sold 5,000 hogsheads of tobacco to Italian people, 2,800 to Spain and 2,000 to the American Tobacco Company. Mayfield Messenger.

Our President's Wealth

Cincinnati, Ohio, April 16. President Taft's personal tax return now on file at the Hamilton county court house here shows that he is \$30,720 richer in property subject to taxation than he was last year.

In that time he has accumulated \$50,000 worth of stocks, while last year he held only \$10,000 worth. His cash has decreased from \$3,720 to \$840 and his debts are listed as \$6,500.

The total value of the president's property is given as \$51,940.

Association Officials at Clarksville Report Large Sales Will the Organization Live?

Clarksville, Tenn., April 16. Notwithstanding the interference of the high waters, which put a stop to all travel except on two roads, the week has been much better in the loose tobacco market than was expected. A large quantity of leaf has been received by the rehanging houses, which has been bought at the barns, while the loose floors have sold 50,000 pounds at good prices. The association salesman here has been quite busy this week, having sold at Clarksville 105 hogsheads and at Springfield 308 hogsheads. Total sales, Clarksville, 1,384; Springfield, 498; Paducah, 339 hogsheads. There is much anxiety in the minds of many, especially of those who have never united with the association, as to whether the organization will be maintained or not. This is the year that all pledges expire and those who have never signed fully realize, and do not hesitate to say so, that they have been greatly benefited through the influence of the organization, and therefore are anxious to have the old members sign again and let them remain independent as heretofore. What the result will be is unknown, as the members intend to wait for the others to sign first.

Hopkinsville, Ky., April 16. Major John W. Breathitt, the father of ex-attorney general James Breathitt, died this afternoon. He was aged eighty-seven.

He was the oldest native of Hopkinsville and was postmaster for eight years until last February.

He was a Union Veteran, and was promoted to the rank of major for personal bravery.

G. W. Housden, a well known citizen who lived east of Hazel, died Thursday morning of this week at his home after a prolonged illness. Some several months ago he contracted the grip which later developed pneumonia. He had about recovered from this illness when he developed piles and contracted blood poison from the effects of which he died. HOME FOLKS

Are Made Defendants in the Famous Suit of Mrs. Latham, of Hopkinsville, for Large Damages

Dr. C. O. Gingles, Dr. Will Mason, of Murray, Milton Imes and J. H. Keys, of Almo, "Billie" Jones, John Creekmur and R. L. Williams, banker, of Kirksey, have been served with notice to the effect that they have been made defendants in the suit of Mrs. Latham, of Hopkinsville, against alleged night riders for the destruction of certain property in the city of Hopkinsville during the raid upon that city in the year of 1907. These well known citizens of Calloway were astounded when served with the notices by Deputy United States Marshall Elwood Neal, and their friends have openly expressed their indignation at the action.

In December 1907 the city of Hopkinsville was raided by night riders and quite a number of tobacco warehouses were destroyed by fire. Among the buildings burned was property of Mrs. Latham, who instituted suit some two years ago to recover for the damages sustained. Suit was first against the city of Hopkinsville but this action could not be sustained and later the suit was filed against a number of citizens of Christian, Lyon and Trigg counties in the federal court at Owensboro.

The damage sought to be recovered is \$50,000 and the case will be called the first of May in the same court at Owensboro.

These well known citizens of Calloway county will be compelled to fight the case at a considerable expense to themselves, while at the same time it is well known that they had nothing to do with the destruction of property in Hopkinsville or any connection with any organization of night riders anywhere. Such a suit is a travesty and goes to demonstrate the absolute rottenness of certain courts of the land.

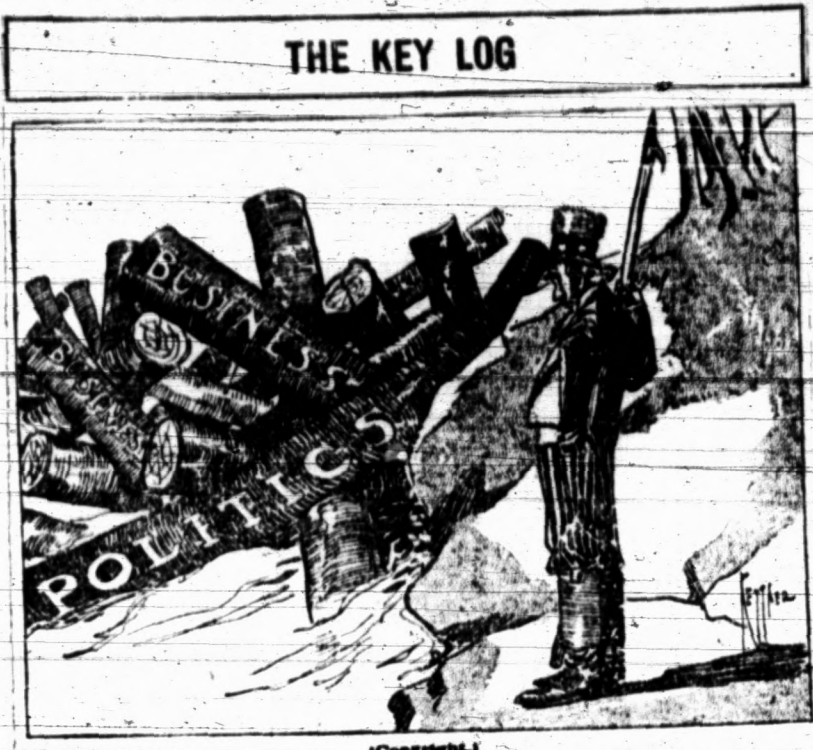

ENGINEERS VOTE TO GO ON STRIKE

FULLY 93 PER CENT OF MEN VOTED FOR A STRIKE

INCREASED PAY DEMANDED

Original Demands of Engineers for Pay Increases Aggregating 15 Per Cent Were Rejected—Wait for Counter Proposition

New York.—The probability of a strike of engineers employed on the city railroads in the Northeastern section of the country was emphasized by the announcement of Grand Chief Warren S. Stone of the Brotherhood of Locomotive Engineers that 93 per cent of the men had voted in favor of the walkout.

This information was dispatched by special messenger to J. C. Stuart, chairman of the conference committee of managers, in this city. Mr. Stuart sent the following reply:

"Will submit your letter to the conference committee of managers for their consideration and action. It will require several days to get the conference committee together, and I doubt whether it can be done before the middle of the latter part of next week."

TO BE TRIED AT HILLSVILLE

Allen Clan Will Not Ask for a Change of Venue

Bristol, Va.—Although a petition for change of venue was filed some time ago by members of the Allen gang who are in jail for shooting up the court house at Hillsville, they have all decided that they want to be tried at Hillsville, according to Judge N. P. Ogelsby of this city, former judge of the circuit court of Carroll and now attorney for members of the clan in the Roanoke jail. Judge Ogelsby said that he advised them that they would be tried in their home county and that they concluded that this would be best.

ADVOCATES FREE SUGAR

Representative of Federal Refining Company Before Senate Committee

Washington.—Frank C. Lowry, representing the Federal Refining Company of New York, resumed his testimony before the senate finance committee in advocacy of the house free sugar bill.

SENATOR BAILEY IS ILL

Walking Typhoid Fever Threatens Texas Senator

Washington.—Senator Bailey is ill and threatened with walking typhoid fever. He sent word to his colleagues that his condition was so much worse as to prevent his participation in the senate's consideration of tariff measures and asked that they proceed without him. The Democratic minority, in courtesy to Mr. Bailey, the ranking Democrat on the finance committee, has been deferring its action.

WILL FIGHT STRIKEBREAKERS

Honolulu, Wash.—In Aberdeen, Wash., women strike sympathizers went to the streets and cut 500 switches, which they decided they would lay on the backs of every morning woman who appeared at the mills with baby buggy, and when the millhouse has been turned on them they have cried that their babies' lives were endangered.

1,350,000 FIRE AT BUTTE

Butte, Mont.—A fire starting in the warehouse section of this city spread into the business district and did damage estimated at \$1,350,000.

WOULD RECLAIM 70,000,000 ACRES

APPEAL FOR GOVERNMENT AID KEYNOTE OF CONGRESS

RAILROADS WILL GIVE AID

Acting President Declares Government Gets Reclaiming Areas and Should Aid in Project

New Orleans.—The reclamation of 70,000,000 acres of reclaimable overflow lands in the United States, and an appeal to the government for assistance were the subjects of the second annual convention of the National Drainage Congress, which began a four-day session here. Drains delayed from ten to fifteen hours by floods prevented many delegates being present to hear the opening address today of Edmund T. Perkins, of Chicago, the acting president.

A message was read by the acting secretary from President Taft, expressing regret because of inability to attend and the hope that much good would result from the work the congress had undertaken.

Gov. Sanders pointed out that the meeting of the congress here was particularly timely, as it was coincident with a tremendous spring flood, when the "greatest artery of the greatest drainage system in the world is being taxed even beyond its capacity to carry off the waters of its tributaries through the Mississippi, the Ohio and the Mississippi valleys."

CHICAGO - NEW YORK WALK

Woman Athlete Will Subside on Raw Foods on Route

New York.—Mrs. David Beach, who proposes to walk from the office of the Globe in this city to the office of the Chicago Daily News, subsiding on route on a diet of raw foods, left New York at 10 o'clock Wednesday morning. She hopes to reach Chicago by June 1. A physician examined her just before her departure and her condition throughout the journey will be watched carefully.

Textile Mills Sold

Greensboro, N. C.—By decree of the federal bankruptcy court the mill properties of the Rhode Island Cotton Mills, Spring Wagon Mills and American Ware house company, all of Spring, N. C., were sold at public auction, bringing a total of \$122,000. The German-American Mills and Lilly Mills, also sold by court decree, brought \$748,000. All of the properties were bid in by the Thread Mill Company of Johnston, Ind., a subsidiary company of the Marshall Field Company of Chicago.

Beef Prices Advance

Denver, Col.—Beef prices have advanced 25 per cent to the highest price paid for beef on the hoof in Denver within the last ten years. Steers at the Denver stock yards brought \$6.50 to \$7.50 per hundred, and cows and heifers \$5.50 to \$7.

ALL FOREIGNERS ARMING

Will Flock to American Embassy in Case of Trouble

Mexico City.—Subjects of Great Britain and Germany living here have joined the American defense colony for mutual protection in case of any uprising against the foreigners is precipitated, through the chaotic conditions now prevailing. The Americans have 1,000 Krug-Jorgensen rifles and plenty of ammunition sent here recently by the United States government.

HARDSHIPS ENDURED BY FLOOD VICTIMS

REFUGEES STAND IN WATER AWAITING RESCUE

105 SHELTERED IN ONE BARN

Stock, Standing Belly Deep in Water, Are Starving or Being Tortured to Death by the Sling of Buffalo Gnats

Memphis, Tenn.—Stories of people rescued from food and huddled in some barn on the muddy, fever night and day, or in house-tops and attics, where brought by the government boat-loads from Earls Landing, Scotland and Pinkney. Many of the refugees brought from the interior had stood on the levee hours at a time in six inches or more of mud.

"Their plight must be experienced to be fully realized," said C. O. Scholter, member of the National Relief Committee.

At one place we fed 105 people in the second story of one barn. They were better fed than many a store had been set up and they were able to keep warm and dry. We left several days' supply of food and will watch them.

"Great gnats are beginning to bother the stock and these poor creatures are suffering severely. Standing belly deep in water for days, they are in no condition to withstand the assaults of the gnats, and many will suffer tortures before death ends their troubles."

"The people are not the only ones to suffer the hardships, though of course we must give our greater efforts to relieving humanity. Clothing is scarce among the refugees, and many a little boy and girl stands knee deep in the mud day and night, without shoes and stockings."

"Some of the refugees brought in on the levee were so weak they could not walk unaided. We have not room for their homes in some instances, and force is necessary to make them board the boats. The great desire to remain at their homes is a striking feature of the situation. Many do not want to leave their stock and goods, and others, whose belongings are lost in the waters, seem too overcome by apathy to desire to leave the scene of disaster."

WOMAN'S NECK TWISTED OFF

Poverty-Stricken New York Woman Mysteriously Murdered

New York.—Mrs. Rose Malchietto, a poverty-stricken widow, was found garroted in her two-room tenement home in West Twenty-ninth street. No money or jewelry was found on her. The woman had no money. A heavy cord was wound three times around her neck, pulled tight and knotted at the back. To make sure of her victim, the murderer had inserted a rubber handle under the cord, making a tourniquet, which he tightened until he choked her purpose. She was apparently attacked while preparing supper and after death carried into the bed room and laid upon the bed.

HANDS MEXICO ULTIMATUM

Federal and Rebels Warned Not to Mistreat Americans

Washington.—Warning was issued by the United States to the Mexican government, as well as to Gen. Pascual Orozco, chief of the revolutionary forces, that it expects and must demand that American life and property within the republic of Mexico be justly and adequately protected, and that this government must hold Mexico and the Mexican people responsible for all wanton or illegal acts of violence or endangering American life or property.

Advance in Wage

Lowell, Mass.—The cotton cloth mills of Lowell announced an advance of 10 per cent in wages. The mills will be reopened to allow the 15,000 operatives on strike or locked out an opportunity to return.

Wheat Jumps Four Cents

Chicago.—Sudden crop reports of the poorest wheat prospects in years east of the Mississippi, an upward jump of 4 cents in May, and the announcement of the transfer of trades by one of the oldest commission houses in the board of trade set the wheat price in a turmoil. Short sellers, some of whom were in a panic and at the tip of the opening bell surged into the pit with a roar to cover their sales.

J. J. Hill to Retire?

Chicago.—James J. Hill, chairman of the board of directors of the Great Northern railway, and one of the country's railroad leaders, will retire, according to a statement published by the Chicago Evening Post. Mr. Hill's place as chairman of the board will be taken by his son, Louis W. Hill, now president of the Great Northern railway. It is said that Mr. Hill, president of the Hill lines in Oregon, will succeed Louis W. Hill as president of the Great Northern railway company. The change will take place about May 1.

Knox Coming Home

Havana.—The American secretary of state called for home Sunday, and will be met by his wife and daughter at the Central American republics and the country in the Caribbean. It was hardly to be expected that Mr. Knox, who could visit so many countries where there are factional political disputes without being made the target of some factional feeling. But with the exception of a few newspaper expressions, to which I attach no great significance, he was received with only the most cordial receptions.

ROOSEVELT WINS IN PENNSYLVANIA

40 OF 64 DELEGATES ELECTED ARE FOR HIM

WILSON CARRIES THE STATE

Roosevelt Will Carry North Carolina, but Will Lose Iowa—He Leads in West Virginia—Delaware Sends Six Delegates Uninstructed

Philadelphia.—The primary election in Pennsylvania resulted in a landslide for Col. Roosevelt.

Of the sixty-four delegates elected in the thirty-two districts, fifty-five are pledged to vote for Roosevelt. Added to this is the probability that the Republican state convention, which will choose twelve delegates at large to the national convention, will be controlled by the anti-Taft element, leaving at least sixty-two delegates for Roosevelt from this state.

With the exception of one or two districts in the state, Woodrow Wilson will have a solid delegation from Pennsylvania to the Democratic national convention.

Dispatches to Roosevelt headquarters from Pittsburgh states that the colored forces carried the shanty city by a majority of 30,000. In some districts in Western Pennsylvania his ratio of victory ran as high as ten to one.

DELAWARE FOR TAFT

Six Delegates Uninstructed, but Sentiment Is Strong

Wilmington, Del.—The Republican state convention at Dover will elect six delegates to the Chicago convention, who will support Taft. The Taft sentiment predominates.

Four of the six national delegates from Delaware will be Senators Richardson and Dupont, Congressman-at-Large Heald and Gov. Pennell. The other two have not been decided upon.

IOWA FOR TAFT

Every County Definitely Decided for Convention

Des Moines, Ia.—With every county definitely decided, it is certain President Taft will control the Iowa convention with a vote of 700 delegates, and not a contested delegation in the convention.

T. R. WINS NORTH CAROLINA

Delegation Will Be Split on Ratio of 16 to 8

Charlotte, N. C.—North Carolina's representation at the Republican national convention will be divided on a ratio of sixteen for Roosevelt and eight for Taft. Announcement to this effect was made by State chairman John M. Morehead after a conference of party leaders to coordinate a new plan of organization in the state.

PRESIDENT WORTH \$51,940

He Has \$840 Cash, and His Debts Are \$6,500

Cincinnati.—President Taft's personal tax return shows that he is \$50,720 richer than he was last year. In that time he has accumulated \$50,000 worth of stocks, while last year he held only \$10,000 worth. His cash has decreased from \$7,220 to \$840 and his debts are listed as \$6,500. The total value of the president's property is given as \$51,940.

Create Health Bureau

Washington.—The senate committee on public health ordered favorably reported Senator Owen's bill to create a national department of public health, to take over the public health and marine hospital service, the bureau of chemistry of the department of agriculture, and the bureau of vital statistics of the census bureau. A delegation of physicians representing the American Medical Association urged President Taft to use his influence to effect the proposed consolidation of all the health bureaus of the government.

Wheat Jumps Four Cents

Chicago.—Sudden crop reports of the poorest wheat prospects in years east of the Mississippi, an upward jump of 4 cents in May, and the announcement of the transfer of trades by one of the oldest commission houses in the board of trade set the wheat price in a turmoil. Short sellers, some of whom were in a panic and at the tip of the opening bell surged into the pit with a roar to cover their sales.

J. J. Hill to Retire?

Chicago.—James J. Hill, chairman of the board of directors of the Great Northern railway, and one of the country's railroad leaders, will retire, according to a statement published by the Chicago Evening Post. Mr. Hill's place as chairman of the board will be taken by his son, Louis W. Hill, now president of the Great Northern railway. It is said that Mr. Hill, president of the Hill lines in Oregon, will succeed Louis W. Hill as president of the Great Northern railway company. The change will take place about May 1.

Knox Coming Home

Havana.—The American secretary of state called for home Sunday, and will be met by his wife and daughter at the Central American republics and the country in the Caribbean. It was hardly to be expected that Mr. Knox, who could visit so many countries where there are factional political disputes without being made the target of some factional feeling. But with the exception of a few newspaper expressions, to which I attach no great significance, he was received with only the most cordial receptions.

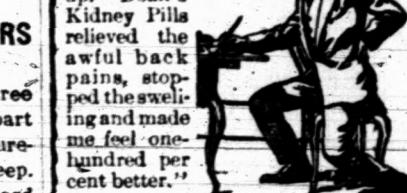

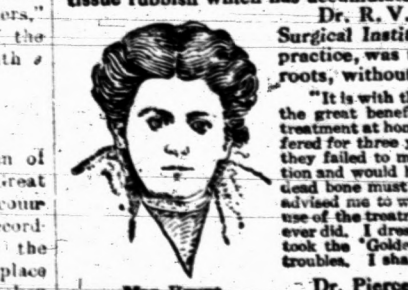

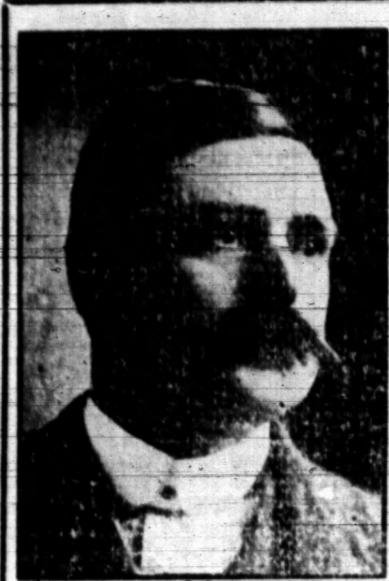

Bloomington, Texas

Bloomington, Tex., April 8, '12 Editor Ledger. At the request of my friends I will write a few lines to the Ledger.

We left Kentucky November 7th, 1911, landed in Memphis at 10 o'clock that night, left the town for New Orleans at 11 o'clock, which we reached at 10 the next morning, left there at 11 o'clock for Houston, reached there at 11 o'clock that night, laid over till 8 o'clock the next morning and we were on our way to Bloomington, which we reached at 2:30 o'clock p. m.

Bloomington is a nice little town, situated about half way between Houston and Brownsville on the St. L., B. & M. railroads, a branch of which will soon be completed to Victoria, the county seat of this county, it is fourteen miles from here to Victoria and 19 miles to Seadrift, on the San Antonio Bay, 39 miles to Port O'Connor on the Gulf. Bloomington is composed of two general Merchandise stores, hardware store, bank, post office, barber shop, two confectionaries, hotel, restaurant, meat market, two land offices, blacksmith shop, cotton gin, feed store, depot, two room school house and an artesian well.

This is a fine country about 13 miles from the Guadalupe river bottom, wood being handy is a great advantage. I have seen as many as 15 wagon loads of wood come out of the bottom at a time, some hauling as far as 40 miles. The plains are fine now, they are well stocked with cattle and horses. I have seen some cattle since I have been out here, have seen as many as a thousand in one drove, that is a sight for a Calaway boy.

Farmers are done planting corn and some of it plowed, some are done planting cotton. Black birds! We have them by the thousands, people have to stay in their corn fields and keep them scared out till the corn gets so they can't pull it up. You ought to see some of our jack rabbits, they look like dogs running over the prairies.

Well if this fails to get to the waste basket I will come again. With best wishes to the Ledger and its many readers. A Calaway boy, Guy Wynn.
