BIG FIRE

Destroys Allen Buildings Together With Contents and Loss Will Reach \$15,000.

Fire of unknown origin completely destroyed the Allen buildings on the north side of the square Saturday night at about 11:30 o'clock together with the stocks of merchandise in both buildings. The five original buildings, the east building occupied by Mrs. DeLaney with a stock of millinery and ready-to-wear ladies clothing and was discovered by Gaius Adams, who was going to his home from the barber shop at the time. The loss includes the two handsome brick buildings; the DeLaney stock; the Kennedy & Buey stock; Dr. Walter Johnson's office upstairs; serious damage to the Wear drugstore building; damage to the Dale & Stubblefield drugstore building; destruction of the cables of both the telephone companies; together with considerable damage to the Wear stock of drugs; Dale & Stubblefield stock; and the O. T. Hale & Co. stock of dry goods by removal from the buildings in which they were located. The total loss will exceed \$15,000. There was no insurance on the buildings, while Mrs. DeLaney carried about \$2,000 on her stock. Kennedy & Buey only had \$1,500 on their large stock. Other losses are fairly well covered by insurance.

Much speculation has been indulged in as to the cause of the disastrous fire and which for a while threatened the entire block, and as a result Deputy State Fire Marshall Parrott was called for by Judge Patterson and spent three days here investigating the matter. It has been reported that about thirty minutes before the fire was discovered a man dressed in a brown suit wearing an auto cap and goggles was seen to emerge from the building occupied by Mrs. DeLaney, but just how much truth there is in such a report is hard to learn. The fire when discovered by Mr. Adams was about the center of the building and every effort possible was made to extinguish the flames. Heroic work upon the part of the volunteer fire fighters prevented the destruction of the business block in which the buildings were located.

Crushed by Train.

Paducah, Ky., January 22. While stealing a ride on freight train No. 50 on the N. C. & St. L. railroad, Calvia Riley, a ne-

gro, 32 years old, of 1026 North Tenth street was killed about 11:30 o'clock Saturday night at Behton, Ky. His left leg was severed and his head was cut and bruised. His cries attracted residents to the track. He died at 5 o'clock Sunday morning.

Riley was on his way to Paris, Tenn., where his wife lives. While stepping from one car to another he missed his footing and fell between. Riley lived with his father and brother here. The train was in charge of Engineer Tom Englert and Conductor S. Moss. The body was brought to Paducah last night.

Jessie, the five year old daughter of Mr. and Mrs. G. T. Miller, of Crossland, died Tuesday night of pneumonia, and was buried Wednesday in Pleasant Grove cemetery. Funeral services were conducted by Rev. L. D. Summers, of Puryear, Tenn. Hazel News.

ASSAULTED

Paducah Furniture Man In Seriously Injured By Noble Wilson, a Young Man of This City.

The Paducah Sun of last Saturday contained the following account of the assault made upon Clifton Hamilton, of that city, by Noble Wilson, who was accompanied by Irvan Forrest at the time. The assault occurred last Saturday night at the depot. Wilson has been arrested and placed under bond. The cause of the attack upon Hamilton will probably develop at the examining trial which is set for Friday of this week. The Sun says:

Called out last night from the passenger station at Murray, Grifford Hamilton, of Paducah, was the victim of two men, who struck him over the head with a heavy bottle. Mr. Hamilton sustained a fracture of the skull, but pluckily returned to his home here. Mr. Hamilton recognized the two men who assaulted him and warrants will be sworn out. He was operated upon last night at Riverside hospital and, although not entirely out of danger, his condition is improved today.

Mr. Hamilton is a representative of the Hamilton Furniture company and spent Friday afternoon collecting in Murray. Last night about 7 o'clock he went to the Nashville Chattanooga & St. Louis railway station to catch the northbound train for Paducah. While in the waiting room he was called to the door by two men and while standing outside on the station platform in the darkness the men asked him his name and when he replied he was struck on the head with a bottle.

Mr. Hamilton is a man of good physique, and, although the blow dazed him, he did not fall. The men ran from the station and disappeared in the darkness. The bottle struck him on the forehead and fractured the skull for two inches and penetrated the nose bone. At first Mr. Hamilton thought the wound was only to the flesh, and tied his handkerchief around his head. He caught the train and returned to Paducah at 8:30 o'clock when, after going to his home, a physician was called to dress the wound.

An examination showed that the skull was fractured and he was taken to Riverside hospital, where the skull was trepanned.
