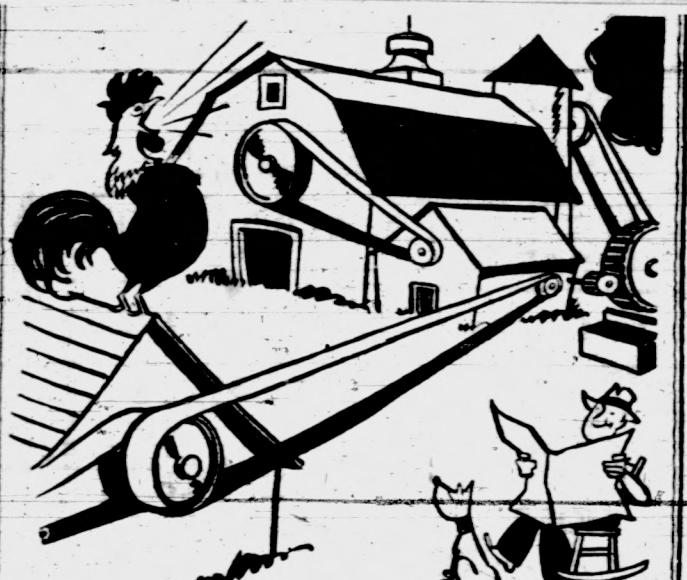

DR. AND MRS. CARR VISIT 12 COUNTRIES

Murrayans Tour Through Great Britain and Continent During Summer.

Twelve countries of Europe were visited by Dean and Mrs. J. W. Carr on their trip throughout Britain and the Continent during the summer from Thursday, June 4, to Tuesday, September 8. England, Scotland, Austria, Hungary, Italy, Belgium, Holland, France, Switzerland,

Germany, Czechoslovakia, and Canada were all included on the itinerary.

"I don't know where to begin and even if I did know I could talk for hours and not be able to tell even a beginning of the wonderful things I experienced on the trip," stated Mrs. Carr when asked to review her trip. "Of course everyone who ever goes to Europe has some special place which he or she desires to visit. I made a specialty of visiting as many literary shrines as possible both in England and on the Continent."

Among the literary shrines visited by Mrs. Carr were the

Robert Browning shrines in Venice and Florence, Italy; the Shelley-Keats Library in Rome, Italy; the home of Dante, Florence; the Byron shrines in Switzerland and Italy; the home of Victor Hugo, Paris, France; the William Tell region in Switzerland; and the place in which Charles Dickens wrote his immortal "Tale of Two Cities".

Dean and Mrs. Carr visited the former homes of many famous writers while in England. In London the homes of Carlyle, Lamb, Thackeray, and Dickens were visited. Other scenes of interest such as the Old Curiosity Shop, Westminster Abbey, Will's Coffee House, Fortune Theatre, built on the site of the old Globe Theatre, made famous by Shakespeare, and the Dickens Library were seen.

A short distance out from London lies Kenilworth Castle, where Sir Walter Scott allowed his imagination to roam and result in the well-known "Kenilworth". This famous castle, which now stands mostly in ruins, was visited by Dean Carr and his wife. Another famous place visited was the church Stoke Pogis, where Gray wrote his famous elegy and where the remains of Gray are now buried.

Many cathedrals were observed by Dr. and Mrs. Carr. Among the most prominent were those at Cologne, Milan, Venice, Florence, St. Peter's at Rome, and the famous Notre Dame cathedral in Paris.

"Those places were simply poems in stone," said Mrs. Carr. "They were beautiful, thrilling, and wonderful."

Among the historic churches where Dr. and Mrs. Carr attended services were St. Paul's in London, Westminster Abbey, in London, St. Peter's, St. Mark's in Venice, and St. Giles in Edinburgh.

"Do you see any signs of depression in European countries?" Mrs. Carr was asked.

"Only in Germany," she replied. "In France things seem to be on the uplift. In the rest of the countries which we visited there were no signs of the depression visible."

Other literary places which Dean Carr and his wife saw were Stratford-on-Avon, birthplace and home of William Shakespeare; the graves of Shakespeare and his wife, Anne Hathaway; Abbotford, home of Scott; Ellen's Isle, where "The Lay of the Last Minstrel" was written; Ayr, home of Robert Burns; Kewyck, home of Coleridge; the famous Falls of Lodore; Dove Cottage, home of Wordsworth; and Oxford University.

Why Not a County Fair?

One of the most commendable, profitable and enjoyable features of life in an agricultural and educational community is the county fair. A number of them have been given in Calloway county this year with splendid results.

Years ago, Calloway used to have one of the best county fairs in this section. That type of fair was not the best and probably one of the greatest reasons for its demise was that attention to agricultural products and art was sacrificed in favor of horse racing, freak shows and gambling devices that invariably followed such events.

However, that old fair served many good purposes and had no little value to the county. The school and agricultural fair, such as is staged nowadays in Calloway county, has eliminated all these repulsive and objectionable features and offers to an interested public only those events, contests and exhibits which are clean and beneficial to all.

But, it strikes us, it would be fitting to hold a county fair at the county seat as a climax to the community fair. Winners of the community fairs could compete at the county fair for the title of "best in the county."

This plan has been tried in other counties and has worked admirably. It is worth much in itself and it also has the added benefit of bringing citizens of various parts of the county into pleasant contact. Many warm friendships between residents of widely separated sections of a county have been made at such county fairs and farmers who never knew others before have obtained much advantage in talking over their common problems.

Management of a county school and agricultural fair could best be handled by an organization of the county high school principals and agricultural teachers, assisted by others in the city of Murray, who would co-operate in arranging details at the

grounds. The county high schools (May we be so bold as to suggest this to the county superintendent of schools and these executives in the county high schools?)

WHAT FARMERS ARE ASKING

If I have a Federal Drouth Seed or Feed loan, can I join the tobacco pool? The federal government gives you authority to become a member of any cooperative organization for the marketing of agricultural products. Your federal, state and county agricultural extension departments endorse cooperative

marketing organizations.

What will kill the bugs in my beans and peas? The pea or bean weevil can be killed by using carbon bisulphide at the rate of one pound to 200 pounds of beans or peas. Place the beans or peas in tight container and set a pan containing the carbon bisulphide on top of the pile. Keep them closed tight for 12 hours or more.

Will it pay me to milk my cows this winter and feed them well? Dairy products have de-

clined 34 per cent in price compared to 40 per cent for other commodities sold in Calloway county. Dairy feeds have declined in price over 50 per cent. With an abundant feed crop on your farm, dairy products will bring greater returns than any other farm product you will sell this year.

October ends the poultry year. If you want to keep a demonstration flock record this year, see the county agent and get your record book.

The good tobacco crop of Calloway county will bring more money if it is properly graded and graded at the time of stripping time. Russel Hunt, tobacco field man for the University of Kentucky and C. O. Dickey, county agent, will hold 10 grading demonstrations in the county, November 30th to December 5th. If you want one in your community, see the county agent.
