cavalry company in 1861, and coming
out as Colonel of the regiment in
1865. He is extremely popular, and
his nomination insures his election.

In the annual report of the Louis-
ville & Nashville railroad just made
to its stockholders it is shown that
the gross earnings for the year end-
ing June 30, 1893, were \$22,399,765,
an increase of \$1,164,070 over those
of the previous year. According
to this the Company will be
enabled to declare an annual divi-
dend of 4 per cent, and have left a
balance of \$600,775. The net
earnings were \$5,071,153. The report
of Mr. Quarrier, the comptroller,
shows that the operating expenses
during the year have been reduced,
compared with the earnings. And,
yet, this is the company that has
just sent out notices to its employ-
ees that on September 1st, their wages
will be reduced 10 per cent. Give
the Louisville & Nashville Railroad
and its employees the same and it would
kick unless somebody fenced it in
free of charge.
