Mr. Borge is sixty-eight years of age and has no children.

Died Last Night.
Mr. R. P. Carnal, who resided between Casky and Edwards' Mill, Sunday night at home. The funeral took place Tuesday morning at 10 o'clock. Mr. Carnal had been sick only a short while. He was about forty years of age, a son of Rev. Mr. Carnal, the Casky minister who was well liked by everybody, and also a brother-in-law of Mr. Thomas L. Graham. Mr. Carnal stood high in the estimation of all who knew him, and his death was a source of sorrow to the entire community in which he lived.

They conducted games at their rooms at the New Richmond Hotel, and were arrested Sunday. About twenty well-known young men who participated in the game have been arrested and will be given a hearing to-morrow.

A Terrible Accident.
A terrible accident occurred at Canfield yesterday morning which cost Miss Dora G. Luman her life. She was a card hand in the cotton mill, and had been employed there for some months. This morning she started to ascend to the work room upstairs in the elevator. The wire elevator cable caught on her neck, broke, and she fell back and killing the poor girl in a few moments. The girl was a general favorite with her associates.

Guilt.
Thomas Smith, who has been on trial before the Breathitt County Circuit Court for the murder of Dr. J. E. Rader, was yesterday pronounced guilty, and his punishment fixed at death. The case has excited much interest. The murder for which Smith is to pay the penalty, was committed about six weeks ago. Rader was staying at the home of a disreputable woman, when in the dead of night Smith entered the house and shot the sleeping man.

OUR INDUSTRIOUS GRAND JURY.
The memory of the present grand jury will live long in the minds of the people. They have shown, even for a grand jury, unusual industry and determination. There is hardly a young man in town whose heart does not beat faster when he sees the grand jury sheriff's approach. For, while of course he knows nothing to fear, yet it is a trying ordeal to face twelve men who are sworn "to pump a man dry." This grand jury has been unparalelled; no class has been spared. The merchant who mistakes a seventeen year old boy for one of eighteen, and seals him in gaol, is indicted along with the hog stealer.

The present jury, as well as we can remember, has broken the record. In one week's work they have returned 56 indictments:
Six for carrying concealed deadly weapons; nine for gambling; one for permitting a minor to play pool; six for selling cigarettes to minors under the age of 18 years; twenty-one for larceny; one for giving liquor on election day; three, selling liquor without license; one, keeping bawdy house; one, petit larceny; one, hog stealing; one, larceny; one, keeping tavern without license; five, fornication.

They will continue in session for at least a bit this week.

PULLIAM,

The Lunatic Murderer of Rev. Mr. Swope, Captured Last.

Rode for a Week Without Rest or Food.

Equal to the Now 120.
Hawesville, Ky., March 14.—Ed Pulliam, the escaped lunatic murderer of Rev. Hargrave Swope, arrived at the home of his father, Thomas Pulliam, at Pateville, at 12 o'clock last night, in the midst of a pouring rain. His horse was so exhausted that it fell, and he had to be riding it for almost a week without food. A priest of citizens and of flowers surrounded the house, and he was captured. He was brought to this city, and will be taken to Hopkinton.

Ed Pulliam was placed in the Western Asylum for the Insane, in this city, yesterday morning.

Planting and Seeding Plants Grow.
There are several ways of rendering the growth of plants both rapid and visible, but the most approved in the "latest improved" experiments is as follows: Take a glass bottle and fill it with a very vigorous plant, a fine plant will grow in the bottle. The other end of this bottle should be attached to a pencil pressing gently against a drum which is being driven by clockwork. If the growth is uniform, a straight line is marked on the paper, but the very slightest increase is shown by inclined lines.
