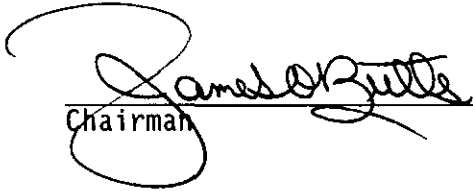
MINUTES OF THE MEETING OF THE BOARD OF REGENTS

September 12, 1993

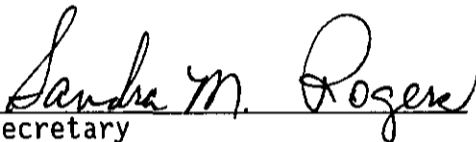

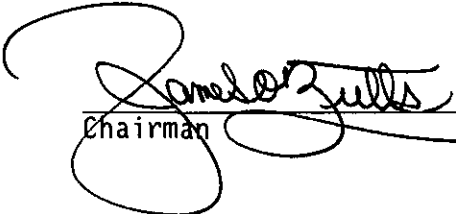

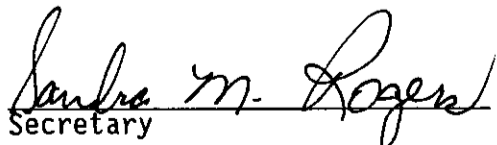
