# UNCLE SAM'S MEN NOW MOVING.

## Sampson Has Been Ordered to Capture Santiago de Cuba at Once,

### WHILE SCHLEY TAKES THE CITY OF SAN JUAN.

#### Naval Experts Say That They Expect to Hear of Fights at Both Places by Tomorrow.

#### ADMIRAL SAMPSON IS NOW IN FRONT OF SANTIAGO.

(SPECIAL TO NEW ERA)  
Washington, June 2.—Secretary of War Alger to-day admitted to newspaper correspondents here that a large number of transports carrying troops, supplies, tools, etc., are now en route for both Santiago and San Juan, Porto Rico. These transports are being accompanied by warships to protect them from any possible danger on route.  
The Secretary did not say just how many men these transports had aboard, but they undoubtedly carried in the neighborhood of 30,000.  
The campaign in Cuba and Porto Rico will begin at once, for the administration now wants to end the war at once, in order to save money as well as human lives.

#### SAMPSON AND SCHLEY HAVE BOTH RECEIVED ORDERS.

(SPECIAL TO NEW ERA)  
Washington, June 2.—The navy department says that orders have been sent to both Rear Admiral Sampson and Commodore Schley.  
Sampson has been ordered to destroy Admiral Cervera's fleet and to capture Santiago just as soon as possible. Sampson, with sixteen vessels, is now before the entrance to Santiago harbor. Commodore Schley was ordered to proceed with the Flying Squadron to Porto Rico and at once reduce the fortifications at San Juan and capture the city as United States troops now en route for that place can be safely landed.  
Commodore Schley sailed for Porto Rico at an early hour this morning, and naval experts expect news of great importance from both Santiago and San Juan by tomorrow.

#### A FIGHT CONFIDENTLY EXPECTED TO OCCUR THIS EVENING.

(SPECIAL TO NEW ERA)  
New York, June 2.—Several ports in Haiti have cabled that they confidently believe that a decisive engagement between Sampson's fleet and that of Cervera will occur this evening at Santiago de Cuba.  
Sampson has sixteen ships with him.

#### THE SPANIARDS STILL LYING ABOUT CERVERA'S FLEET.

(SPECIAL TO NEW ERA)  
New York, June 2.—A cablegram from London says that Spanish officials still declare that only one vessel of Cervera's fleet is in the harbor of Santiago de Cuba.  
This is known in the United States to be simply a Spanish lie, because Commodore Schley and Capt. Sigsbee ran the St. Paul sufficiently far into the entrance of the harbor to see and recognize four of Cervera's fleet. Then, again, on last Sunday two of Cervera's torpedo-boat destroyers came out and attempted to blow up the battleship Texas.

#### SAMPSON WILL ANNIHILATE ADMIRAL CERVERA'S FLEET.

(SPECIAL TO NEW ERA)  
Washington, June 2.—Uncle Sam is now preparing to deal Spain a blow that will be as crushing as her defeat at Manila.  
Just as present all other projects against Spain in the West Indies are to be suspended, and the army and navy are to unite in delivering a blow at Santiago which will render Spain powerless to undertake any offensive naval movements and which will at the same time give the United States a firm foothold on Cuban territory.  
This second experience of the overwhelming power of the United States, it is hoped, will be such an object lesson to Spain as to convince the Sagasta Ministry of the futility of longer continuing the struggle. It is hoped that after this second complete victory for the American arms, Spain will see for herself and will cease this country of the necessity of continuing this war further, at the expense of many Spanish lives as well as those of Americans.  
It is especially desired that the bombardment of Havana, with the loss of life and destruction of property, which would be inevitable, may be avoided.  
Another factor in the situation which the Administration believes will tend to shorten the war is the announcement that the bank of Spain can supply the Government of that country with no more money. It is believed a second defeat coincident with a financial crisis at Madrid, will render Spain powerless to continue the war.  
It is suggested that following the taking of Santiago and the capture or destruction of Admiral Cervera's fleet, the European nations may make representations to Spain as to the hopelessness of continuing the struggle further, and may advise the Queen Regent to accept the most favorable terms of peace she can secure from the United States. What these terms of peace will be will depend largely upon developments.  
Spain may yield all her possessions on the Western Hemisphere. No terms of peace that contemplated anything else would be for a moment considered.  
It is suggested in some quarters, however, that the United States might let go the Philippines and take Porto Rico as a permanent territorial possession, maintaining, however, a protectorate over Cuba, after having kept an army there long enough to enable a firm government to be established, in accordance with the wishes of the people of the island.

#### ESCAPE FOR ADMIRAL CERVERA IS NOW IMPOSSIBLE.

(SPECIAL TO NEW ERA)  
Washington, June 2.—Rear Admiral Sampson is now off Santiago de Cuba and has relieved Commodore Schley in command of the entire force of vessels operating against Santiago and the Spanish fleet. He has assigned Commodore Schley to the command of a division comprising the ships formerly attached to the Flying Squadron.  
Fifteen warships are at Admiral Sampson's disposal to pit against the six men-of-war flying the Spanish flag. They include the first-class battleships Iowa, Oregon and Massachusetts, second-class battleships Texas, armored cruisers New York and Brooklyn, protected cruisers New Orleans, Marblehead and Minneapolis, gunboat Nashville, torpedo-boat destroyers Scorpion, dynamo cruiser Vesta, torpedo-boat Porpoise, auxiliary cruisers Harvard and Yale and the auxiliary gunboat Eagle.  
With such a force blockading Santiago de Cuba, naval experts who have heretofore contended that Admiral Cervera had a fighting chance to escape now concede that his position is absolutely hopeless.

#### THE INSURGENTS MAKE AN ATTACK UPON SANTIAGO.

(SPECIAL TO NEW ERA)  
Kingston, Jamaica, June 3.—The Spanish Government, according to advices received here from Havana, intends to cut the cables which connect that city with Key West, if the other Cuban cables are cut by the Americans.  
The Havana papers, the same advices say, published a dispatch from Madrid declaring that the Americans intend to attack Santiago de Cuba, while the insurgents are making an attack by land, and also to land reinforcements at Guantanamo, East of Santiago.  
The surrender of the Spaniards is expected.

#### ATTACKING SANTIAGO!

(SPECIAL TO NEW ERA)  
New York, June 2, 4 p. m.—The World's Haytian cable says Schley renewed the attack on Santiago de Cuba at an early hour this morning—attacking the fort batteries, doing great damage.  
More mines were laid by Cervera, but Schley destroyed them.  
The Cubans are attacking the town in a bloody and determined fight—attacking it from three sides.  
The surrender of the Spaniards is expected.

# Ridiculous Spanish Lies.

## Washington, June 2.—El Pionero, of Havana, a copy of which has reached here, published a summary of the situation from a Spanish point of view May 23. It said:

"A month has gone by since the cowardly Yankees proclaimed they were against Spain. They then declared that they would annihilate us, that they would take Havana and level our forts to the ground. We now see that it was but a cowardly boast, for not one dashingly Yankee has set foot on Cuban soil. 'Wherever the ships of the enemy have been driven back with disastrous loss and their attempts have resulted in the destruction of their ships. They tried to starve us, but on the contrary they are starving themselves, for bread and meat are higher in New York than they are in Havana. We have plenty to eat while the Yankees have been compelled to open free soup houses in all the big cities to feed their hungry and people die from starvation."

#### Tomatoes Are Heroes.

The enormous purchases of canned tomatoes by the United States Government have almost depleted the markets of the country, and housekeepers may find it difficult to obtain supplies of this popular vegetable this summer in many portions of the country. The wholesale grocers report an increased demand for canned goods of all kinds, but especially tomatoes, and prices have advanced largely in consequence. Fresh tomatoes are also higher than this season in former years, a condition which dealers ascribe to the scarcity of the canned article. The canning houses are buying heavily in advance, and if the demand continues the prices will be sky high all season. Housewives who expect to put up canned tomatoes and make tomato catsup, etc., this year in sufficient quantity to last all next winter need not be surprised if they have to pay more for the fruit than in former years.

#### The Questions Asked.

The following facts will no doubt be of interest to those who contemplate eating in the regular army. Whether married; any one dependent on the applicant for support; ever been convicted of any crime or been imprisoned in a jail or penitentiary; ever attended school, and how long; ever served in the United States or any foreign army, stating particulars. The applicant is required to furnish two testimonials from well-known citizens, preferably clergymen, school teachers, or public officers, testifying to the character of the applicant, and stating that he sustains a good reputation in his home community for morality and temperate habits, and that the person applying will, in the belief of the person furnishing the testimonials, make a good and faithful soldier.
