CAN YOU PICK THE WINNER?

ALL FOUR CANDIDATES ARE HOPEFUL. DARK HORSE POSSIBLE. What The Aspirants Say About Their Chances To Win.

The convention to nominate a Democratic candidate for the court of appeals from the First appellate district takes place in Paducah on Monday, July 21, and country man's convictions will be held on Saturday, July 19.

The four aspirants for the nomination are Judge J. D. White, of Carroll; E. H. Robbins, of Graves; Circuit Judge Thomas P. Cook, of Carroll; and Circuit Judge T. J. Nunn, of Hopkinsville. All are popular men, with strong followings.

The official call for the convention follows: "The convention to nominate a Democratic candidate for the court of appeals from the First appellate district of the State of Kentucky at 2 o'clock p. m., on July 19, 1902, shall appoint delegates to attend a general conference to be held at Paducah, Ky., on July 21, at 10 o'clock a. m., for the purpose of nominating a Democratic candidate for judge of the court of appeals from the First appellate district of the State of Kentucky."

"All Democrats shall be allowed to vote in said county mass convention which will be held at Paducah, Ky., on the evening of July 20, and such voters as will have reached the age of 21 years before the regular November election who agree to support the nominee of said district convention."

Miss Cora was standing on the deck of a yacht, and playfully asked Hobson if he would rescue her if she fell overboard.

FATE OF BLACK MISSISSIPPI FIEND. HUNDREDS IN THE MOB. Father of the Brute's Victim Applied Torch to the Faggots. (Special to New Era.)

CLAYTON, Miss., July 17.—William Ody, a black fiend, was killed by a mob last midnight. He was tortured to death. Hundreds of men were in the lynching party, and they burned the negro at the stake. He was tied to a tree, faggots saturated with oil were piled about him, and the father of the negro's victim applied the torch.

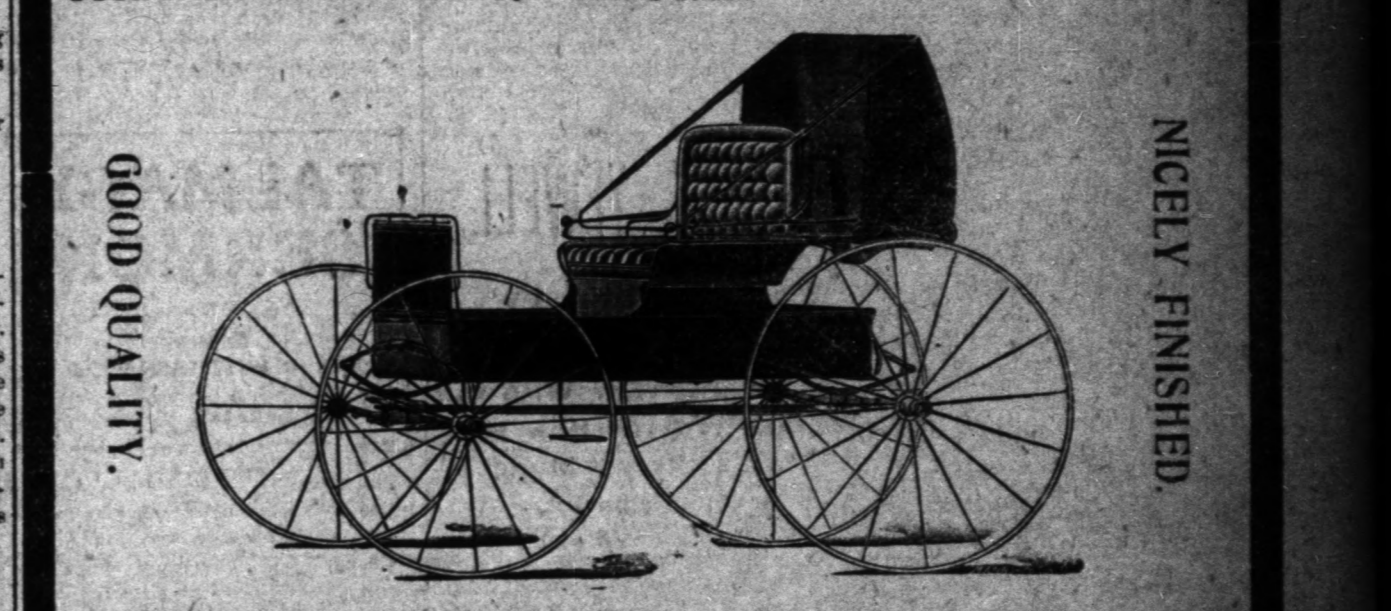




