## SCHOOL BOOKS

Other Books Must be Substituted in Place of the American Book Company.

Important Letter to County Superintendents

### SCHOOL BOOK QUESTION.

Frankfort, Ky., Apr. 8.—State Superintendent Fuqua, in a circular letter addressed this morning to County School Superintendents of Kentucky, calls their attention to a judgment of the Mason Circuit Court for \$10,000 against the American Book Company, being the full amount of its bond to counties under the old system, and notifies them that it is necessary, the company refusing to renew this bond, that all counties having such contracts shall cancel them, and at once substitute the books of the State uniform series. The letter, which is of wide interest, is, in full, as follows:

The Court of Appeals having affirmed a decision of the Mason county Circuit Court against the American Book Company, by which Mason county got a judgment for \$10,000, the full amount of said company's bond, under and by authority of which said American Book Company secured the adoption of certain text books for use in the various counties of this State, under the former county adoption law, sections 60 and 61 of the old school book law, the same being sections 4, 423 and 4,424 of the Kentucky Statutes, and as said American Book Company refuses to execute a new bond for the continuance of the said county adoption of its text books, now under contract in certain counties (unexpired county adoptions), you are hereby notified that it will be unlawful for the common schools of the Commonwealth to continue using, any of the text books published by the said American Book Company on any such county adoptions contracts, as all such county adoptions are forfeited by said company by its refusal to execute a new bond for the continuance of such county adoptions, the provisions of the law relative to such county adoptions being as follows:

Upon the failure or refusal of any such publisher or person to comply with the provisions of this act within the time herein specified, the text books of such publisher or person selling the same shall be removed from the common schools of any and every county by the County Board thereof in which the same have been adopted.—[Kentucky Statutes, Section 4,424.

It will therefore be required of all counties having such contract for text books published by the American Book Company to discontinue their use from and after this date and substitute for such books the corresponding books of the State uniform series. The penalties for using other books than the State series, except such as are under legal contract, are upon the County School Book Commission and teachers, the former being liable to a fine of from \$100 to \$500 and the latter (teacher) cannot draw salary while using other books than those under legal State or

county contract. This applies only to the publications of the American Book Company at present. Other suits are pending against other companies and you will be advised on the conclusion of these. The Court of Appeals holds that only one recovery can be made against any one company, and such recovery shall be for the full amount of the bond. Mason county has been awarded the amount of the American Book Company's bond and other suits against it will be useless.

## TO PRACTICE MEDICINE.

**You Must Take the Examination April 25.**

Examination of all applicants who desire license to practice medicine in Kentucky will be held in Louisville on April 25 at

the Galt House by the examining board of the state board of health. All persons desiring to practice medicine in this state must be examined on April 25 or they will have to wait six months for the next examination. It is expected that a large number of young medical students will apply for licenses. The new law regulating the practice of medicine in Kentucky requires every applicant for a license to stand an examination under the state board of health, these examinations being held twice each year.

## TOBACCO CBOP.

Will fall short from last year say Dealers and Farmers.

Farmers and dealers who profess to know, do not believe that there will be anything like as much tobacco planted this year as last. They believe also that the statement that more canvas for plants bed has been sold this year than last is incorrect. Even if it be true they do not think that it argues a larger crop. Under the ruling of the Dark Tobacco Protective Association, the raisers plant early, and every bed sown will require canvas.

The increased purchases of canvas or at least a large number of applications for canvas, do not indicate increasing sowing of plant beds.

Another reason for increased purchases is that on account of the low prices of last year many farmers took the canvas off their beds or threw it away or hung it on the fence with the intention of not using it again.

Much of this has become worthless. This has not been so in former years. The snow which last April ruined a great deal of canvas, then in use. One of the most important reasons for the appearance of increased purchases is that the merchants did not put in as large a stock of canvas, as usual, expecting that the crop would be very short. The result is that a farmer has to go to several stores before they can obtain the amount of canvas they need. The farmer who are coming to tobacco houses say that there will be a material cut in the acreage.

Very little tobacco is being brought to Mayfield now. It is expected, however, that large quantities will be brought in when there is a good season.

28, 1902 and began the great work of soliciting private subscriptions received in that way \$31,441.94. To this was added \$75,000 appropriated by the State legislature, making a total of \$112,362.16 which the commission received. This commission returned to the State treasury the sum of \$2,832,02 of cash expended, besides other exhibits &c to the amount of \$7,955.85. **Knocked off to W. A. Usher, Who was the Highest Bidder at \$6,300.**

The entire plant of the Beaumont Soap Company was sold this afternoon at 2 o'clock, by Mr. Z. T. Long, receiver, for \$6,300 to W. A. Usher. The stock of soap on hand was sold first to Pete Burnett for \$1550. The plant was then sold including the house and lot and machinery for \$3600 to H. W. Brantley, of Memphis. The material on hand was put up and sold and was bought by H. W. Brantley for \$160.

Then it was all put up and sold in a lot which brought \$6300. There was a big crowd present but only a few bidders. The plant and all valued at \$69,000 was sold for the above amount. It is not known whether the plant will continue to be run here or not.
