TODAY'S SPORTS PARADE

Reg. U.S. Pat. Off.

NEW YORK 13.—The clouded
controversy of why runners Mal
Whitfield and Wes Santee aren't
eligible in the current voting for
the Sullivan Award was cleared up
today with official disclosure that
both still are under investigation
which could end their amateur
careers.

"Something is hanging over
their heads," explained Daniel J.
Ferris, secretary-treasurer of the
National AAU. "This award is
based on sportsmanship and char-
acter as well as ability."

Which means, Ferris pointed out,
that the award would look ridicu-
lous if "something broke" about
the time either one of them might
possibly be named as the winner
of the honor bestowed annually
on the nation's outstanding am-
ateur athlete.

Named for the voting were three
track stars, two divers, two swim-
mers and a weight lifter.

They are J. Lewis Papa Hall,
University of Florida high jumper;
distance runner Charles Capozzoli

and hurdler Nancy Phillips; De-
troit weight lifter Norbert Sche-
mansky; divers Pat McCormick
and Sonny Lee and swimmers
Jimmy McLane of Yale and Gail
Peters of Washington.

The storm broke when this list
was announced because both Whit-
field, the former Ohio State dis-
tance star, and Santee, the Kansan
who set a new American mile
mark, were missing. Certainly, it
was generally conceded, they
should have been on the list.

Because in the past year, Santee
galloped to a new American mark
of 4:02.4 for the mile and, to show
it wasn't a fluke, followed with a
4:03.7 clocking. He is regarded as
America's chief hope for the long-
sought four-minute mile.

Whitfield had ever greater rec-
ord achievements to boost his
claim. He broke world records at
a half mile and 1,000 meters and
set indoor marks for 500 and 600
yards, winning 14 straight races.

The charges, as revealed by Fer-
ris, were that Whitfield tried to
"hold up the promoters" of a meet
in Sweden while, he said, the
charges against Santee were "of
a more personal nature."

Ferris said that queries to the
Swedish amateur athletic officials
had resulted in the forwarding of
newspaper accounts of Whitfield's
alleged demands on promoters
"but no charges from the officials
themselves."

"There was criticism of Santee's
actions during a tour of Europe,"
Ferris added. "Thus, according to
the information in our hands at
this time, they could not qualify
for the award."

With the continuing investiga-
tion keeping Whitfield and Santee
off the ballot, meanwhile, it is
possible that Mrs. McCormick or
Miss Peters will give the women
athletes a long-sought victory in
the voting.

Medical School Is Recommended

Frankfort, Ky.—Recognizing the
need for additional physicians in
Kentucky, the Advisory Committee
on Medical Education to the Leg-
islative Research Commission rec-
ommended to the 1954 General As-
sembly, as a long-range plan, es-
tablishment of a school of medicine
at the University of Kentucky "as
soon as the Commonwealth's fi-
nances permit."

In addition, the committee rec-
ommends construction of a teach-
ing hospital with a minimum 500-
bed capacity; construction of a
medical sciences building suffi-
cient to accommodate classes to grad-
uate 75 doctors a year, together
with adequate residence facilities
for nurses and internes.

The group also recommended
that pending establishment of the
new medical college, the present
contractual arrangement with the
University of Louisville on medi-
cal research be continued, together
with arrangements for training of
additional students through the
Southern Regional Education
Board.

Members of the Advisory Com-
mittee making the study were Drs.
Edward H. Ray, chairman, Lexing-
ton; J. Vernon Pace, Paducah;
Clyde C. Sparks, Ashland; Bran-
ham B. Baughman, Frankfort, and
Clark Bailey, Harlan.

The committee found that there
is a definite shortage of physicians,
dentists, nurses and allied medical
personnel and facilities, along with
a critical shortage in rural areas,
accompanied by inadequate teach-
ing and training facilities.

The only medical college in Ken-
tucky is unable, without the guar-
antee of increased financial sup-
port, to expand its capacity to
train more Kentucky students as
doctors.

The committee recommended that
the Rural Kentucky Medical
Scholarship Fund might be expand-
ed, or that adoption of a medical
loan plan for rural areas be in-
augurated, similar to a plan in
force in Mississippi.

ON KENTUCKY FARMS

Farmers in Green county this year grew 21,000 acres of corn, compared to 31,245 acres in 1930. Measures have been taken to control Japanese beetles in Covington, where the insect has been found in two sections of the city. George Spoonamore of Lincoln county has built a milk room and milking parlor from University of Kentucky plans. In Marshall county, there are 318 homemaker-members in 17 homemaker clubs. Twelve homemaker clubs in Muhlenberg county assisted in the county clean-up campaign by serving lunches to workers. Maurice L. Graves, operator of an 80-acre dairy farm in Ballard county, has been named district Master Pastureman. Despite drought, some farmers in Powell county had a better corn crop than they grew last year. Improvements in Caldwell county include two irrigation systems, two upright silos, one trench silo.

a pole-barn and feeding sheds. LaRue county homemakers are emphasizing the importance of a basic dress with different accessories for various occasions. Members of 18 homemaker clubs in Ohio county are learning how to make braided rugs. Lewis county farmers having certain strains of chickens have been offered a year round price of 77 cents a dozen for eggs. The drying up of creeks and springs resulted in a number of ponds being dug in McCreary county. G. C. McWhorter & Sons and Elmer Boles of Clinton county have changed stanchion-type milking parlors to the walk-through type.
