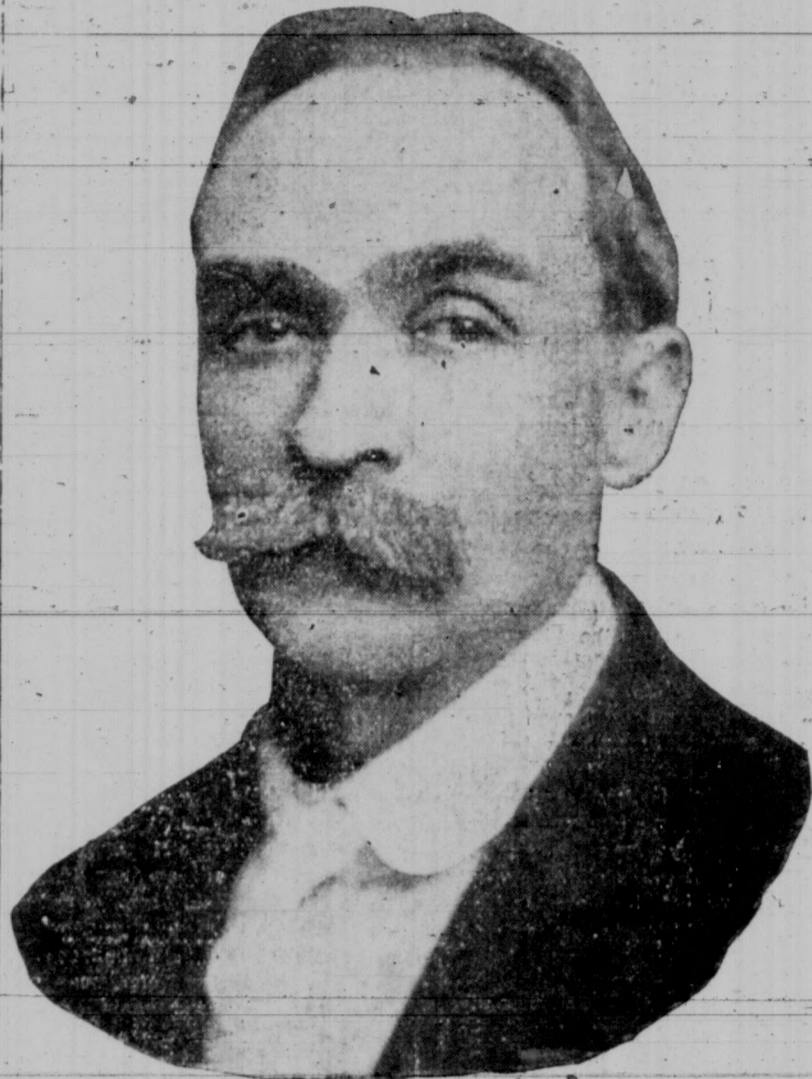

DARK TOBACCO AVERAGE \$6.22

FRANKFORT, Ky., Aug. 12.—Three million two hundred and six thousand, eight hundred and thirty-two pounds of the 1920 crop were sold during July on Kentucky markets, according to the monthly reports of all tobacco warehouses given out here by W. C. Hanna, commissioner of agriculture. This tobacco brought \$550,494.40, an average of \$10.93 a hundred pounds.

Fired dark tobacco sold for growers from the 1920 crop totalled 365,490 pounds, bringing \$22,736.30, an average of \$6.22.

No Green River or unfired dark tobaccos were sold.

There were no sales for growers and no resales of this variety.

Children Cry for Fletcher's

RAY HOWARD PLED OF MURDER CHARGE

Ray Howard, who shot and killed Ed Allison at the home of Sulton Humphreys near Hazel on the night of March 10, was acquitted of the charge of Murder in the Calloway Circuit Court Thursday morning after the jury had deliberated the case for some several hours.

The trial of Howard was called Tuesday morning of this week and during the two days trial it was before the court house was packed to its capacity. The second day of the trial it was found necessary to lock the court house doors to prevent overcrowding the building. Two days were consumed in hearing the evidence and the arguments and the jury did not get the case until 7 o'clock Wednesday night. The commonwealth made a strong endeavor to convict Howard and Commonwealth Attorney Smith was assisted by County Attorney Joe Lancaster and J. H. Coleman in the prosecution of the case. The state attempted to show that Howard had gone to the home of Humphreys where Allison had been a guest for supper and where he was invited back later to play cards, and that when Allison stepped upon the porch of the Humphreys home he was shot and killed by Howard who by hiding at the end of the porch behind a clump of vines.

Howard was represented by Wells, Weeks and Hood, of this city, and Fitzgugh and Lewis, of Paris, Tenn. His testimony was that he had gone to the home of Humphreys where his estranged wife was staying and just about the time he reached the house he noticed that someone was following and that he stepped to the end of the porch to await the arrival of the individual Howard stated that while standing there he was fired upon by Allison without warning. The ball from Allison's pistol passing through his hat. Howard then commenced firing, resulting in the death of Allison.

Mr. Howard lived near Almo in this county for some time and it was while they were residing there that trouble arose between himself and wife. They separated and she went to the home of Sulton Humphreys, a brother, near Hazel, and where the killing took place. Mr. Howard left Calloway and went to reside with his father near Paris. He made many friends while living here and the verdict of acquittal was anticipated by those familiar with the case.
